






#### Happy New Year!

The ball in Times Square has dropped, and the New Year has begun. Many people utilize the beginning of the New Year to reflect on their goals and to make resolutions to obtain those goals. In December, the City Council met to review what has been accomplished in 2012 and to set their goals for 2013. The following goals were formally adopted at the Council meeting on January 2, 2013:







- <u>Finance:</u> To adopt and maintain a sustainable budget that reflects City priorities and realizes current economic conditions.
- <u>City Policies & Procedures:</u> To review and evaluate the City Charter, ordinances, and policies to provide for the current and future needs of the citizens.

With each of the five goals, the Council identified the top priorities for each goal and various activities aimed at achieving those goals. For example, some of the identified activities under the Infrastructure and Services goal includes: (1) completing the Empire Pedestrian and Bicycle Access Project (see page 2 for more information on this project); (2) completing the Eastside Boat Ramp Expansion project by constructing a new fish cleaning station; and (3) completing the Parks Master Plan. #### **Major Improvements Ahead for South Empire Blvd**




In March 2012, the City of Coos Bay was awarded \$2.1 million for Phase 1 of the "Empire Pedestrian and Bicycle Access Project." The purpose of the project is to increase pedestrian and bicyclist safety through the widening and overlay of South Empire Blvd from Newmark Avenue to Fulton Avenue, and the installation of bicycle lanes, sidewalks, and lighting on both sides of the street. The project will also include the installation

of some viewpoints such as a covered shelter / CCAT bus stop and the creation of some on-street parking along Empire Boulevard. Construction work could begin within a few months.

The City has submitted a grant application to the Oregon Department of Transportation to help with Phase II of the project (S Empire Blvd. between Fulton and just south of Wisconsin Ave) which is estimated to cost \$1.6 million dollars. ODOT initially received 155 proposals, but only 53 projects have moved forward to the public input portion of the process. Here is an opportunity to provide public comment on the Empire Pedestrian and Bicycle Access Project. Comment period ends January 31, 2013. An online survey will collect input.

ODOT will use the input to help determine which projects to recommend for formal approval by the Oregon Transportation Commission in March 2013; funds will then be awarded beginning in July 2013. Your help and input could help make the completion of this project possible.



#### **ePermitting**

The City of Coos Bay was to "GO LIVE" with the statewide ePermitting online permit system on October 1, 2012. However, technical difficulties related to capacity with the State of Oregon's system that hosts ePermitting, our "GO LIVE" date had to be postponed. **We now expect to "GO LIVE" January 15, 2013.** 

General contractors and others will be able to apply for virtually all types of building permits (that the City issues) via the ePemitting system. The ePermitting system is the culmination of a multi-year effort on the part of the Oregon Building Codes Division (BCD) and cities like Coos Bay. That effort has been funded by a surcharge on building permit fees to create the nation's first statewide electronic permitting system. ePermitting is based on software developed by the Accela Corporation for use by governments. Accela has contracted with the state to provide this system at no additional purchase cost to the participating jurisdictions.

The new program and an earlier, less robust, version have been very well received by the contractors using it, as it has brought convenience and savings to their business practices, while encouraging the act of obtaining necessary permits through the ease of use. It has been a benefit to system users. The time factor has been a big plus for using the system. The system is also easy to use.

The new system will allow contractors and property owners to apply in person or on-line for all types of building permits; plan review and routing can be tracked and followed in the system. Fees can be assessed and paid online with a credit card. In fact, because the system is web-based, eligible parties can apply and pay from anywhere on the planet. This accessibility is a real benefit to general contractors and others that have a need for building permits. An inter-active voice response (IVR) system is included that provides the ability for builders to schedule/request inspections from a pre-selected menu. The system will even e-mail a response to your designated address or smart-phone. Additionally, the BuildingPermits.Oregon.gov web-site for ePermitting has a "citizen access" function that will allow people to access the electronic building department files, request inspections, and track many of the system features.

Maintaining files and records of permits is required by law; the ePermitting system will take on most of that costly burden, as relating to building permits anyway. As Coos Bay staff learn and grow into the system, they are sure other advantages will come to light. For example, Coos Bay received expensive Adobe 10 Pro software (at no charge) for use with the plan review functions performed by many city staffers.

#### Christmas Tree Pickup

#### Smoke Detector Give Away

Coos Bay Fire & Rescue still has some new smoke detectors to give-away. The smoke detector give-away program was made possible through grants provided by Bay Area Hospital and our local Wal-Mart.

To be eligible to receive a free smoke detector you must meet the following requirements:

- You must be a resident of the City of Coos Bay.
- You must own or be in the process of purchasing the home (not available for rentals).
- Must be over the age of 65 years old or have children under the age of 12 years old living in the home.
- For those with children living in the home, your total household income must be lower than \$65,000 annually.

There is a limit of one smoke detector per household. Smoke detectors can be picked up at the main fire station located at 450 Elrod Avenue, Monday – Friday from 8:00 a.m. to 5:00 p.m. If needed, the Fire Department personnel can install your smoke detector for you.

#### Free CPR Class

Coos Bay Fire & Rescue will be sponsoring an Adult Family & Friends Cardiopulmonary Resuscitation (CPR) course. The Family & Friends CPR Course teaches the lifesaving skills of adult Hands-Only® CPR, child CPR with breaths, adult and child AED use, infant CPR and relief of choking in an adult, child, or infant. Skills are taught in a dynamic group environment by using the American Heart Association's (AHA) research-proven practice-while-watching technique which provides students with the most hands-on CPR practice time possible. Family & Friends CPR is for people who want to learn CPR but does not need a course completion card in CPR for their job. This course is ideal for schools and students, new parents, grandparents, babysitters and others interested in learning how to save a life.

The course will be given on Thursday, **January 17, 2013** from **6:00 pm to 8:00 pm** and will be held at Coos Bay Fire Department's main station located at 450 Elrod Avenue. #### 7 Tips on Preventing Identity Theft

In the course of the day, you do many activities that put your personal information at risk — from writing a check at the store to charging merchandise in person or over the phone. You may not think twice about these transactions, but others might. Identity theft — when a perpetrator assumes someone's identity for personal or financial gain, like stealing a credit card to make financial transactions in the victim's name — is the fastest-growing crime in America. According to the U.S. Postal Inspection Service, there were almost 10 million cases of identity theft which cost consumers \$5 billion.



The National Citizens' Crime Prevention Campaign, sponsored by the National Crime Prevention Council, aims to educate consumers about what they can do to prevent identity theft. The council offers the following tips:

- Do not give out your personal information unless you initiate the contact or know the person or company with whom you are dealing. Also, never disclose personal information, such as a Social Security number or bank account number, in response to an email. Legitimate businesses will not ask you to do this.
- Do not disclose your credit card number to an online vendor unless it is encrypted and the site is secure. Look at the first part of the Web address on your browser. It should read "https://."
- Do not write your Social Security number or telephone number on checks or credit card receipts.
- Remove all documents with personal information from your hard drive before discarding your computer or sending it in for repair.
- Shred discarded documents, including preapproved credit card applications, bank statements, store receipts, and utility bills. "Dumpster divers" can gain access to your personal information if such items are thrown in the trash.
- Cancel all credit cards that have not been used in the last six months. Open credit is a prime target for thieves.
- Order your credit report at least twice a year and report any mistakes to the credit reporting agency in writing.

If you are a victim of identity theft, contact your local police department as soon as possible. If your identity was stolen in one jurisdiction but used in another, you may have to report the crime in both jurisdictions.
