Hello Henry and Jake,

I am following up on an e-mail I sent to Henry this past Fri., May 10 regarding submissions for the second open record period deadline of Land Use Appl. #187-18-000153 (Jordan Cove, NRI). I have a couple of clarifications, and I was hoping I could get your help.

First, my understanding of this Thursday's deadline (May 16) is that it is permissible to submit materials into the record so long as they respond to matters raised between March 21 and April 25. Is that correct?

Second, I have been unable to locate site specific criteria for the 55-CA segment within Comprehensive Plan Vol. 3. Could you please direct me to location of the relevant management objective and use table for 55-CA?

Hello Henry,

I had a question about next week's second open record period deadline (Thurs. May 16 2019) for Jordan Cove Energy Project Land Use Application #187-18-000153. The "Notable Projects" section of the Community Development site states that open record period (dated Apr. 18, 2019) states that:

"There is a second open record period from Friday, April 26, 2019 to 5 PM on Thursday, May 16, 2019. Comments during this period are limited to matters raised during March 21-April 25, 2019 public comment period."

I wanted to clarify the types of submissions that would be permissible so long as they are "limited to matters raised during March 21-April 25, 2019 public comment period." Would it be permissible to submit additional documentation/evidentiary material in addition to a substantive written comment to respond matters raised between March 21-April 25, 2019?
