The Jordan Cove Energy Project is a really bad direction for Coos Bay in spite of all the money they are offering to spend for it. Planning commissioners, please do not support a change an area of the Coos Bay Estuary from Natural Aquatic (NA) to Development Aquatic (DA).

Only 21% of estuaries of Washington, Oregon and Northern CA. have eelgrass. The eelgrass in the South Slough of Coos estuary is decreasing.
