Attending remotely was Board Member Cora Vandervelden.		
12	Approval of the March 31, 2021 Meeting Minutes		
13	Chair Vandervelden called for a motion to approve the Minutes.		
14 15	Board Member Miller moved and Board Member Lagasse seconded the motion to approve the March 31, 2021, minutes as presented. Motion carried by unanimous vote.		
16	Introduction of New Operations Administrator		
17	New Operations Administrator, Greg Hamblet introduced himself to the Board.		
18	Citizen Input/Public Comment		
19	There was none.		
20	Hall Street Tree Removal Update		
21 22 23	Staff Member Hossley reported the removal of the trees has been put on hold due to citizen complaints and stated Patrick Myers inspected the trees and determined they are healthy and growing. Mr. Hossley stated the sidewalks will be replaced when the City has funds to do so.		
242526	A discussion commenced regarding the trees not being in good shape, that they are well beyond years for street trees and should be removed. It was noted that abutting property owners had been advised of the City's decision to not remove the trees at this time.		
27	570 S. Wall Tree Removal Update		
28 29	Staff Member Eck reported he has not had a chance to assess the trees and will move it up on his priority lists.		
30	Coos Head Food Co-Op Tree Planting Update		
31 32 33	Staff Member Eck reported the trees have not been planted because of water and natural gas lines in the proposed planting location and that there have been discussions with the applicant about using planters.		
34 35 36	A discussion commenced regarding the desire to have trees in that location and the Board requested Staff to investigate the depth of the utility lines in hopes that trees can be planted. Staff Member Hamblet will reach out to the waterboard and gas company about the depth of their utilities.		

Staff Member Burnette advised the Board the applicants would like to plant low laying bushes in

lieu of trees and that Randy Dixon had advised the applicants that the Board would determine the

bushes to be planted and get back to them.

- The Board discussed the desire to plant trees as originally designed in the 4th Street Roadway
- 42 Safety Improvement project currently underway. The Board expressed concern about hodge-podge
- 43 planting which the City is trying to get away from and the fact that the applicant should still be
- 44 able to have outdoor dining and an awning for their restaurant.
- 45 Board Member Miller moved and Board Member Lagasse moved to maintain the street tree
- 46 planting on 4th Street as designed. Motion carried by unanimous vote.

47 Planting on Newmark Avenue

- 48 Staff Member Eck stated this issue has been before the Board before and a decision needs to be
- 49 made as to the species the Board would like to see planted along the Newmark Avenue corridor
- 50 where trees were removed due to the trees extending in to the utility lines.
- 51 The Board discussed different species that would be good for that location and would not grow
- 52 into the utility lines. Board Member Miller proposed planting Norway Maples along the Newmark
- 53 corridor.
- 54 Board Member Lagasse moved and Board Member Miller seconded the motion that the Board
- 55 follow Board Member Miller's recommendation to plant Norway Maples along Newmark Avenue.

56 620 Commercial Avenue Tree Removal Request

- 57 Staff Member Eck reported the tree is causing damage to the sidewalk, the abutting property
- 58 owners' sewer lateral, and is in the utility lines. Staff Member Eck further reported City Staff
- 59 trimmed the tree last year to assist with the utility line interference.
- 60 The Board discussed removing/killing the tree to keep it from causing further damage, maintaining
- 61 good rapport with the property owners and the fact that the tree will continue to cause problems
- 62 underground if it is not removed.
- 63 The Board also discussed the need to provide maintenance of City trees and that they need to be
- evaluated before they get too big or too old.
- 65 Board Member Childs moved and Board Member Miller seconded the motion for City Staff to
- 66 remove/cut the tree.

67 Board Member/Staff Closing Comments

- 68 Board Member Allen requested Staff provide all City Departments with a copy of the City's tree
- 69 planting plan.
- 70 Board Member Childs asked if the City's GIS was going to be updated with the tree inventory he
- 71 made. Staff Member Hossley stated the City's GIS Coordinator can do that if provided with the
- 72 information. Staff Member Hamblet asked how the GIS information/tree inventory would be
- 73 maintained. It was discussed that if the Board provided the information, the City could update it
- 74 on the map.

- 77 Chair Vandervelden adjourned the meeting at 12:47 p.m.
