This is a Letter of interest for consideration of appointment to fulfill a vacancy on the City Council for William Lee Davis.

I have lived in Coos Bay for three years and I am buying my house at 1058 Anderson, and I am not now nor have I ever been, a city employee.

My reason for interest for the appointment is that I have come to care deeply for the people of Coos Bay and I want to be part of making sure they all get a chance to live a good and productive life in a beautiful community.

I have never served on the City Council but I feel that my education and experience will serve me well in my service to this community.

Educational experiences:

I am a graduate of Burns Union High School, Burns Oregon. I attended Southern Oregon State College for two years before I got married and enlisted in the Air Force during the Viet Nam era.

I was given the opportunity from the Air Force to return to college and receive my Bachelors degree from Oklahoma State University in Business Administration. After graduating I went to Officer's Training School to become a commissioned officer.

I received my first Masters degree from Pepperdine University in Public Administration while I was serving in the Air Force as a Personnel Officer in 1977.

After being honorably discharged at the end of the war, I went back to school and received my Master of Divinity from McCormick Theological Seminary in 2001.

Employment experiences:

After I was discharged from the Air Force, I held various positions as a Human Resources Manager for companies in Southern California.

When we decided that our children needed to be educated in Oregon like we were we move to Salem where I was hired by the state to write position descriptions for state employees. When that temporary position ended I obtained a position with the state as a Jobs Case Manager. We helped people qualify and receive public assistance, but our priority was to help them find employment and get off the system asap.

When my wife realized she was called into ministry and was accepted at McCormick Theological Seminary in Chicago; I resigned my position, packed up a U-haul truck and moved to Chicago.

My first priority was to find employment to support her call to ministry. I worked for the Chicago Family services department as a case manager, then I transferred to the State Employment Office to help people find work and finally I worked for a private employment service developing positions for our clients to fill in the community.

When I realized that I was being called to ministry as well, I worked for manpower to help pay for our education.

I have been a pastor of churches in Indiana, Minnesota, and Oregon. I am currently a ¼ time pastor for the 1st Presbyterian Church of Coos Bay. We are a small congregation and we sold our old large building to the city for the Fire station.

Other community experiences of interest.

I was a certified court mediator in Medford Oregon and I am still active in mediation for Neighbor to Neighbor Mediators. Since the Ecumenical Ministerial Association was no longer active, so I restarted it in 2009 and I am now the president for about 30 members.

I have been a Red Cross water safety instructor, and a community college instructor.

I am applying for the open council position in order to be even more active in serving this city. I believe we need to do as much as we can to improve the lives of people who live here and make visitors feel invited and welcome.

MINUTES OF THE PROCEEDINGS OF THE CITY COUNCIL

January 17, 2012

The minutes of the proceedings of a regular meeting of the City Council of the City of Coos Bay, Coos County, Oregon, held at 7 p.m. in the Library Meeting Room, 525 Anderson Avenue, Coos Bay, Oregon.

Those Attending

Those present were Mayor Crystal Shoji and Councilors Jennifer Groth, Stephanie Kramer, Gene Melton, John Muenchrath, and Mike Vaughan. City staff present were City Manager Rodger Craddock, Finance Director Susanne Baker, Intermediate Accountant Debbie Frankenberger, Economic Revitalization Administrator Joyce Jansen, Public Works and Development Director Jim Hossley, Library Director Samantha Pierson, Fire Chief Stan Gibson, and Police Sergeant Eric Schwenninger.

Flag Salute

Mayor Shoji opened the meeting and asked Howard Forte to lead the Council and assembly in the salute to the flag.

Public Comments

No comments were given.

Consent Calendar

Mayor Shoji reviewed the consent calendar which consisted of 3a: approval of the minutes of January 3, 2012; 3b: acceptance of December 2011 accounts payable and payroll check registers; and 3c: acceptance of the December 2011 combined cash report. Councilor Melton moved to approve the consent calendar approving the minutes of January 3, 2012, accepting the December 2011 accounts payable and payroll check registers, and accepting the December 2011 combined cash reports. Councilor Muenchrath seconded the motion which carried with Mayor Shoji and Councilors Groth, Kramer, Melton, Muenchrath, and Vaughan voting aye.

Presentation by Executive Director Roger Langlie of the Bob Belloni Ranch

Executive Director Roger Langlie rescheduled his presentation to the February 21, 2012 City Council Meeting.

Appreciation Plaque to Howard Forte

In consideration of Howard Forte's service on the Budget Committee from February 20, 2007 to December 31, 2011, Mayor Shoji presented Mr. Forte an appreciation of service plaque. Mr. Forte expressed his thanks and stated it was a pleasure to serve on the committee. Mayor Shoji thanked Mr. Forte for his dedication and volunteer effort.

Filing of the Urban Renewal Annual Financial Impact Statement for Fiscal Year 2010/2011 with the City Council

Economic Revitalization Administrator Joyce Jansen stated Oregon Revised Statutes (ORS) 457.460 required a financial impact statement from the Urban Renewal Agency be filed with the Council by January 31st of each year. The report complied with ORS 457.460 and was in addition to the Urban Renewal Budget adopted on June 7, 2011 and the Urban Renewal Agency Audit accepted on December 6, 2011. Ms. Jansen explained the components of the financial report and noted the report was available on the city's website or at the Finance Department during normal business hours. The purpose of the urban renewal was to improve specific areas of the city which were poorly developed or underdeveloped, eliminate blight, and encourage economic development. Ms. Jansen noted major projects during 2010/2011 included the downtown traffic circulation project, Coos Art Museum elevator, Library HVAC system, Hollering Place Wayside, Boat Building Center, Empire Blvd. sidewalk project, and façade grants. Councilor Groth inquired regarding the status of John Zhen's façade grant wherein City Manager Rodger Craddock stated the grant was extended to May 31, 2012. Councilor Kramer moved to approve the filing of the Urban Renewal Annual Financial Impact Statement for Fiscal Year 2010/2011. Councilor Melton seconded the motion which carried with Mayor Shoji and Councilors Groth, Kramer, Melton, Muenchrath, and Vaughan voting aye.

Approval of an Emergency Operations Plan

Fire Chief Stan Gibson stated the Emergency Operations Plan (EOP) was an all-hazard, all-scale plan providing framework for the City of Coos Bay to respond and recover from emergencies and disasters. Chief Gibson explained the Coos Bay EOP addressed systems and strategies for agencies, facilities, operations, and personnel relied on during an emergency and was primarily applicable to extraordinary situations and was not intended for day-to-day emergency situations. The EOP was developed in cooperation with Coos County and the City of North Bend, used best practices recommended by FEMA and Oregon Emergency Management Agency, and functioned as a bridge among local, state, and federal emergency management systems. Councilor Muenchrath asked if the EOP included provisions for a food bank wherein Chief Gibson replied provisions for a food bank were included in the EOP and stated the Council and staff would be trained on all aspects of the EOP on Saturday, January 21, 2012. Councilor Melton moved to approve the 2012 City of Coos Bay Emergency Operations Plan. Councilor Kramer seconded the motion which carried with Mayor Shoji and Councilors Groth, Kramer, Melton, Muenchrath, and Vaughan voting aye.

Approval of a Revised Coos Bay Boat Building Center Management Agreement

City Manager Rodger Craddock stated the city entered into a three-year management agreement with the Coos Bay Boat Building Center (BBC) in January 2010 which included an annual management fee of \$8,000, paid quarterly. Due to structural issues the BBC could not use the building for the past year and temporarily relocated to the Business Incubator in North Bend. Mr. Craddock stated the BBC Board of Directors requested a revised management agreement to extend the term an additional ten months and increase the management fees. The proposed agreement would begin January 1, 2012 and end December 31, 2013; fees would be paid monthly rather than quarterly and would increase to \$14,400 annually (\$1,200 monthly) for 2012 and \$9,600 annually (\$800 monthly) for 2013. The total cost of the

agreement was \$24,000 which would be paid out of the Hotel/Motel fund. Mr. Craddock stated the BBC Board of Directors were in the process of completing their business plan with the goal of becoming self-sufficient by January 1, 2014. The center re-opened in its permanent location earlier this month and classes were already underway, a gift shop opened and many donations of boats and tools were made. Mr. Craddock concluded the BBC was a key component of the Hollering Place, served as an educational and recreational facility, and helped to preserve the city's boat building heritage noting the city's financial assistance with BBC operational costs would help the center be successful and fulfill their mission. Councilor Kramer moved to approve the proposed management agreement and authorize the City Manager to execute the agreement. Councilor Melton seconded the motion which carried with Mayor Shoji and Councilors Groth, Kramer, Melton, Muenchrath, and Vaughan voting aye. BBC Board President Jim Berg thanked the Council for their support over the last two and one half years. Mr. Berg stated the BBC was fully functional, had in excess of 100 members, had abundant volunteer opportunities, and urged the Council members and community to visit the facility which was now open on Saturdays.

Council Appointment to the Coos Bay/North Bend Visitors & Convention Bureau

City Manager Rodger Craddock stated due to Councilor Joanie Johnson's resignation an appointment was needed to fill the City's vacant position on the Coos Bay/North Bend Visitor & Convention Bureau (VCB) Board. The appointment was for the duration of the vacant term ending November 20, 2012. Mayor Shoji expressed interest in the VCB position if someone was interested in her position on the board of the Oregon Coastal Zone Management Association (OZCMA). Councilor Kramer volunteered to take over Mayor Shoji's position on the OCZMA board. Councilor Groth moved to appoint Mayor Shoji to the Coos Bay/North Bend Visitor & Convention Bureau Board. Councilor Melton seconded the motion which carried with Mayor Shoji and Councilors Groth, Kramer, Melton, Muenchrath, and Vaughan voting aye.

City Attorney's Report

No report was given.

City Manager's Report

City Manager Rodger Craddock stated there was one open position for the City Council and three openings for the Planning Commission and the deadline to submit applications was January 27, 2012. One letter of interest was submitted for the Council position and three applications were submitted for the Planning Commission with interviews to be held prior to the Council meeting on February 7, 2012.

Mr. Craddock stated a company was interested in leasing property for one dollar per year at the Visitors Information Center to construct an electric vehicle charging station with solar capabilities. The company would maintain the property and would require two parking spots. Councilor Vaughan asked the elapsed time to charge an electric car at a level 4 charging station and Mr. Craddock replied under twenty minutes. Mr. Craddock also stated the City was contacted by a company interested in leasing an unused sewage pipeline located under the bay between Empire and the north spit to run fiber optic lines. The pipeline was built for wastewater but may not be large enough for the original purpose intended.

Council Comments

Councilor Kramer thanked the fire department for their quick response when she had her accident. Councilor Muenchrath stated on Friday January 20, 2012, Move to Amend would participate in a one day occupation of the Federal courthouses across the country to mark the second anniversary of the Citizens United versus the Federal Elections Commission decision by the U.S. Supreme Court. Councilor Muenchrath supported their efforts to reject the decision and supported their move to amend the Constitution to establish corporations are not people and money is not speech and requested the Council support this amendment. Councilor Melton expressed concern regarding the intersection located at Merchant and Jackson streets and felt stop signs should be installed at the northwest and southwest corners of the four way intersection and asked staff to investigate. Mayor Shoji urged members of the community to apply for the open Planning Commission positions and stated it was great experience for other community leadership positions. Ms. Shoji enjoyed being involved with the Coquille Tribal Community Fund and the annual award of 2011 grant funds.

There being no further business to come before the Council, Mayor Shoji adjourned the meeting. The next regular Council meeting was scheduled for February 7, 2012 in the Meeting Room at the Coos Bay Public Library.

On January 10, 2012, the Planning Commission voted unanimously to recommend approval to vacate the north 15 feet of a portion of Division Avenue located between Fenwick and Crocker Streets; also described as the north 15 feet of Division Avenue abutting Lot 9 of the Plat of Colton Estates, found in Section 17DA, Township 25, Range 13 West of the Willamette Meridian, Coos County, Oregon.

BACKGROUND

The applicant, Mr. Don Ivy, 756 Sanford Street, owns the property abutting the proposed vacation area. Division Avenue also abuts John Topit's Park.

Division Avenue is platted 30 feet in width from Seagate to Crocker Streets and is currently undeveloped. There is a 10-foot wide platted pedestrian walking path abutting the east side of the subject property and provides access to Empire Lakes and John Topit's Parks, which will not be altered or affected by the proposed vacation.

The area proposed for vacation is currently fenced and is being used by the applicant as yard area. Approval to fence the undeveloped right of way was granted in March of 1998 by Right-of-way Use Permit #MIS98-00061.

In 2001 the City approved a similar vacation of the North 15-feet of Division Avenue (between Seagate and Augustine Streets), abutting 760 Augustine Street. It was determined by staff that future development of Division Avenue is very unlikely due the elevation changes and that the remaining south 15-feet of Division Avenue would provide a buffer for the John Topit's Park from residential uses.

ADVANTAGE

Vacating the north 15 feet of Division Avenue as proposed increases property taxes slightly.

DISADVANTAGE

The area proposed for vacation will not be available for public purposes in the future.

AN ORDINANCE PROVIDING FOR THE VACATION OF THE NORTH 15-FEET OF DIVISION AVENUE, BETWEEN FENWICK STREET AND CROCKER STREET, ABUTTING LOT 9, OF THE PLAT OF COLTON ESTATES, SECTION 17DA, TOWNSHIP 25 SOUTH, RANGE 13 WEST OF THE WILLAMETTE MERIDIAN, COOS COUNTY, OREGON.

The City of Coos Bay ordains as follows:

Section 1. Donald Ivy filed a petition for the vacation of a portion of Division Avenue, between Fenwick Street and Crocker Street, within the City of Coos Bay, more particularly described as follows:

Beginning at the Southeast corner of Lot 9, Plat of Colton Estates; thence, West along the northerly right of way line of Division Avenue a distance of 75.07 feet more or less to the southwest corner of Lot 9; thence, South a distance of 15.00 feet; thence, East, parallel to the north right of way line of Division Avenue, a distance of 75.07 feet more or less; thence, North a distance of 15.00 feet to the TRUE POINT OF BEGINNING.

RETURN TO: City of Coos Bay 500 Central Avenue Coos Bay OR 97420 **Section 4.** Public hearing was held before the Coos Bay Planning Commission on January 10, 2012, in the Coos Bay Library, at the hour of 6:00 p.m. at which time and place all persons had an opportunity to appear and object to the vacation of the above-described real property.

Section 5. After careful consideration of all evidence and testimony presented during the public hearing, the Planning Commission found that the public interest would not be prejudiced by the vacation of the above-described real property and recommended the City Council vacate the above-described area.

Section 6. Having reviewed the Planning Commission's findings of fact, conclusions and final recommendation and the record of the public hearing held on February 7, 2012, the City Council hereby adopts the following findings of fact and conclusions of the Commission:

- (1) Donald Ivy submitted notarized petition of consent of all abutting property and twothirds in area of the real property affected thereby.
- (2) Notice procedures under ORS 271.110 have been complied with.
- (3) The proposal does not conflict with the comprehensive plan, including the adopted Coos Bay transportation system plan or other ordinances.
- (4) Granting the requested street vacation will not prejudice the public interest.

Section 7. The Port Commission of the Port of Coos Bay has consented to the vacation of the above-described street as stated in Resolution 90/91 -14 adopted March 20, 1991.

Section 8. The City Manager shall have prepared within a reasonable time an intelligible map of the property hereby vacated and the City Recorder shall cause the map to be filed with this ordinance in the office of the County Clerk, Coos County, Oregon.

Section 9. It is hereby declared that public interest will not be prejudiced by the vacation of the above-described street, that such vacation is in the best interests of the City of Coos Bay, and that the City of Coos Bay does hereby vacate the entire area described in Section 1 of this ordinance.

Section 10. This Ordinance shall take effect 30 days after enactment by the Council and signature by the Mayor, whichever is later.



Mrs. Barron stated the Head Start project has begun; the permits for The Maritime Center has been issued; A rezone regarding the proposed sewer plant in Empire will come before the Planning Commission, with a Conditional Use permit to follow at a later date; the floodplain ordinance must be updated due to new maps; and another street vacation request will be heard at the February meeting.

Commissioner Harlan asked if we will be revisiting the Empire Design Standards. Laura Barron stated the City Council will review a staff report on February 21, 2012 to determine if they want design standards and, if so, what type of standards.

Chairman Coles stated the Parks Commission will be reviewing the Park Master Plan. She stated there are new signs at John Topit's Park and they will review options for a dog park.



FINAL RECOMMENDATION

Recommend City Council approve Vacation application #ZON2011-00062, based on the Findings and Conclusions set forth below, for the vacation of a portion of the Division Avenue, between Fenwick and Crocker Streets; also described as the north 15 feet of Division Avenue abutting Lot 9, Plat of Colton Estates Plat, found in Section 17DA, Township 25, Range 13 West of the Willamette Meridian, Coos County, Oregon.

APPEAL PROVISION

The final decision will be made by the City Council, and this decision may be appealed to the Land Use Board of Appeals pursuant to ORS 197.830.

Questions regarding the appeal procedure may be directed to the Public Works and Development Department, City Hall, 500 Central, Coos Bay, Oregon or phone (541) 269-8918.

DECISION PROCESS - EFFECTIVE DATE

The Planning Commission makes a recommendation to the City Council after hearing public testimony and addressing the applicable decision criteria from Coos Bay Municipal Code Chapter 17.375.050. Based on their conclusions, the Commission will make a recommendation to approve, approve with conditions, or deny the application. Conditions may be used by the Commission in order to address concerns about the proposed request.

The Council shall review the record and affirm, amend, or reverse the Commission recommendation, or remand the matter back for further consideration.

Upon approval of a proposed vacation and/or fulfillment of conditions, the City Council shall have prepared an ordinance which declares the land to be vacated and specifies the conditions under which the vacation is made. The proposed vacation will become effective upon enactment of the ordinance.

EXHIBIT A

DECISION CRITERIA, FINDINGS & CONCLUSIONS

The following is a list of the decision criteria applicable to the request, Coos Bay Municipal Code 17.375.050. Each of the criterion is followed by findings or justification statements that may be adopted by the Planning Commission to support their conclusions. Although each of the findings or justification statements specifically apply to at least one of the decision criteria, any of the statements may be used to support the Commission's final decision.

Based on their conclusions, the Commission must recommend approval, approval with conditions, or recommend denial of the application. Conditions may be used by the Commission in order to address concerns about how the applicant will meet the criteria applicable to the request.

DECISION CRITERIA #1: Consent of the affected property owners has been obtained.

STATEMENTS OF FACT AND FINDINGS:

1a. The City received the required notarized signatures of all abutting property owners and the required notarized signatures of property owners in the affected area.

CONCLUSION: Consent of the affected property owners was received. The decision **criterion** has been adequately addressed and approval can be supported.

DECISION CRITERIA #2: Notice has been duly given.

STATEMENTS OF FACT AND FINDINGS:

- On December 6, 2011 the Coos Bay City Council approved the applicant's request to initiate the vacation process.
- 2b. The Public Works and Development Department has given notice of the hearings in accordance with Coos Bay Municipal Code (CBMC) Chapter 17.300 and state statute. Notice of the time and place of the hearings were:
 - Published in "The World" newspaper on December 20 and December 27, 2011:
 - Posted in two conspicuous locations in the area of the vacation on December 21, 2011 (Division Avenue at Fenwick and Crocker Streets and posted at City Coos Bay City Hall and Library); and
 - Mailed to all property owners within 250 feet of the area to be vacated on December 16, 2011.

CONCLUSION: The decision criterion has been adequately addressed since all notice required by the Coos Bay Municipal Code and state statute has been given. Approval of the proposal can be supported.

DECISION CRITERIA #3: The proposal does not conflict with the comprehensive plan, including the adopted Coos Bay Transportation Plan, or other ordinances.

STATEMENTS OF FACT AND FINDINGS:

3a. After reviewing the city's comprehensive plan, including the Coos Bay Transportation Plan, and other ordinance provisions, city staff did not find any specific conflicts between the city's regulations and the proposed vacation.

CONCLUSION: The decision criterion has been adequately addressed and approval of the proposal can be supported.

DECISION CRITERIA #4: The public interest will not be prejudiced by the vacation.

STATEMENTS OF FACT AND FINDINGS:

- 4a. Division Avenue is platted 30 feet in width from Seagate to Crocker Streets. Division is currently undeveloped.
- 4b. The 10-foot wide platted pedestrian walking path abutting the east side of the subject property and provides access to Empire Lakes and John Topit's Parks, will not be altered or affected by the proposed vacation.
- 4c. The area proposed for vacation is currently fenced and is being used by the applicant as yard area. Approval to fence the undeveloped right of way was granted in March of 1998 by Right-of-way use permit #MIS98-00061.
- 4d. In 2001 the City approved a similar vacation of the North 15-feet of Division Avenue (between Seagate and Augustine Streets), abutting 760 Augustine Street (Vacation #2001-8024). According to Finding "4d" of Final Order #MIS2001-00051 "Steve Doty "Steve Doty, Operations Administrator inspected the site and Determined future development of Division Avenue is very unlikely due the elevation changes. He added the remaining south 15-feet of Division Avenue would provide adequate buffer for the Empire Lake Park from the proposed residential use." (Attachment C)
- 4e. Published notice and mailed notice of hearings concerning street vacations provide the public and affected utilities agencies with an opportunity to express their opinions concerning a proposed vacation. The published and mailed notice indicate written comments may be submitted prior to the hearing.
- 4f. A written response (e-mail) was received on December 20, 2011 from Ron Hoffine, Coos Bay/North Bend Water Board, indicating the Water Board has no comments or objections to the proposed vacation (Attachment D).
- 4g. A written response (e-mail) was received on December 27, 2011 from Fire Chief Stan Gibson indicating the Fire Department had no issues with the request (Attachment E).
- According to City records there are no storm drain or sewer lines in the proposed vacation area.

4i. The proposed vacation is not located within 1,000 feet of the harbor and as provided by Resolution 90/91-14 the vacation of streets in areas in excess of 1,000 feet from the harbor and pierhead lines will not have an adverse effect on transportation or commerce with the Port district therefore, the Board of Commissioners approves all proposed streets vacations.

CONCLUSION: The remaining south 15-feet of Division Avenue will provide adequate buffer for the Empire Lake Park from the existing residential use. The decision criterion has been adequately addressed and the public interest will not be prejudiced by the vacation.



In an effort to ensure the auditing services are competitive and reflective of the current economy, a Request For Proposal (RFP) was solicited from December 14, 2011 through January 17, 2012 for the City of Coos Bay and the Coos Bay Urban Renewal Agency. Because of the economy of scale in advertising, the Coos Bay North Bend Visitor Convention Bureau was also included and they will approve their auditing services separately. The RFP was advertised twice in The World and five times in the Daily Journal of Commerce. The City received three inquiries of interest: Pauly Rogers and Company, Tigard; Hough, MacAdam, and Wartnik, North Bend; and Merina and Company, West Linn. Two proposals were received for the entities, as follows:

The RFP review process included a separate, independent review by Finance and the City Manager with the City Manager concluding the following:

- 1. Both companies have complied with the basic requirements of the RFP.
- 2. Both companies have the necessary experience and have demonstrated their ability to complete the work.
- 3. Pauly Rogers appears to have a greater depth in personnel and experience with municipal auditing.
- 4. Pauly Rogers has indicated efficiency in the hours (340 hours versus 400 hours) required to perform the services, which are reflected in the fees.

Subsequently, the City Manager directed staff to forward to the Council a recommendation to award the contract to Pauly Rogers and Company.

<u>ADVANTAGES</u>

The soliciting of the RFP provided the City the opportunity to assure the continued independent, quality auditing services that the City has been receiving are competitive with the current economic climate. The RFP also afforded the opportunity to other qualified firms to submit a proposal.

DISADVANTAGES

None.

The auditing fees were anticipated during the FYE 12 budget process and were appropriated.

RECOMMENDATION

If it pleases the City Council, award the auditing services contract to Pauly Rogers.

<u>ISSUE</u> Overturn Corporate Personhood

BACKGROUND

Corporate personhood is the position conferred upon corporations under the law which allows corporations to have rights and responsibilities similar to those of a natural person. At the January 17, 2012 council meeting, Councilor Muenchrath requested the City Council consider approving a resolution that supported amending the Constitution that opposes the Supreme Court's interpretation of the Constitution in *Citizens United* regarding the constitutional rights of corporations to provide that corporations are not entitled to the entirety of protections or "rights" of natural persons.

Since the Supreme Court's ruling in Citizens v. Federal Election Commission in 2010 upholding the rights of corporations to make political expenditures under the First Amendment, there have been several calls for a US Constitutional amendment to abolish Corporate Personhood.

Resolution 12-04

A RESOLUTION OF THE CITY OF COOS BAY, COOS COUNTY, OREGON APPROVING A CONSTITUTIONAL AMENDMENT TO OVERTURN CORPORATE PERSONHOOD

Whereas, In 2010 the United States Supreme Court issued its decision in *Citizens United v. Federal Election Commission*, holding that independent spending on elections by corporations and other groups could not be limited by government regulations; and

Whereas, This decision rolled back the legal restrictions on corporate spending in the electoral process, allowing for unlimited corporate spending to influence elections, candidate selection, and policy decisions; and

Whereas, In reaching its decision, a majority of the Supreme Court, relying on prior decisions, interpreted the First Amendment of the Constitution to afford corporations the same free speech protections as natural persons; and

Whereas, In his eloquent dissent, Justice John Paul Stevens rightly recognized that "corporations have no consciences, no beliefs, no feelings, no thoughts, no desires. Corporations help structure and facilitate the activities of human beings, to be sure, and their 'personhood' often serves as a useful legal fiction. But they are not themselves members of 'We the People' by whom and for whom our Constitution was established"; and

Whereas, The Court's decision in *Citizens United* severely hampers the ability of federal, state, and local governments to enact reasonable campaign finance reforms and regulations regarding corporate political activity; and

Whereas, Corporations should not be afforded the entirety of protections or "rights" of natural persons, such that the expenditure of corporate money to influence the electoral process is a form of constitutionally protected speech; and

Whereas, several proposed amendments to the Constitution have been introduced in Congress that would allow governments to regulate the raising and spending of money by corporations to influence elections;

NOW THEREFORE, BE IT RESOLVED THAT, THE COOS BAY CITY COUNCIL OF THE CITY OF COOS BAY, OREGON opposes the Supreme Court's interpretation of the Constitution in *Citizens United* regarding the constitutional rights of corporations, and supports amending the Constitution to provide that corporations are not entitled to the entirety of protections or "rights" of natural persons, specifically so that the expenditure of corporate money to influence the electoral process is no longer a form of constitutionally protected speech, and calls on Congress to begin the process of amending the Constitution.
