ISSUE: Presentation on Downtown Parking Enforcement.

BACKGROUND:

Through a power point presentation, Coos Bay Police Department staff will present an overview and provide some historical insight of the downtown parking enforcement program. The enforcement of the downtown parking has been handled in several different ways over the years; however, most of those years it has been enforced through means of a part time employee, generally managed by the Police Department. The entire enforcement/collection process has been a collaboration of staff members from several entities throughout the city and requires a fair amount of staff time.

As of late, the downtown parking enforcement has been suspended, due to the lack of staff resources and higher demands placed on current staff members. Through this presentation, it is staffs' goal to provide you with knowledge needed in order to make an appropriate recommendation as to whether or not downtown parking enforcement is a feasible priority at this time.

Staff will provide some statistical information and walk Council members through the life cycle of a parking citation. At the conclusion of the power point presentation, several options will be presented to Council members for their review and direction as to how staff should proceed.

ADVANTAGES:

An informed council is better prepared to answer and address citizen inquiries in regard to the downtown parking enforcement concerns.

BUDGET:












