ISSUE: Urban Renewal Advisory Committee

BACKGROUND:

During goal setting in December, the City Council selected encouraging citizen input and volunteerism in city government as one of the top priority goals and the creation of an Urban Renewal Advisory Committee is listed as one of the Council's short term activities. As a result, staff contacted a number of Oregon cities for information on urban renewal advisory committees. Ten cities were contacted, and seven of those cities have advisory committees. Based on the study, the makeup of the committee may be comprised of any or all of the following: residents or property owners within the district, any combination property owners and citizens at large within the district, members of the city council, and representatives from the overlapping taxing districts. Other entities that could be represented on the committee are the Coos Bay Downtown Association, Community Coalition of Empire, and Eastside Neighborhood Committee. There are nine overlapping taxing districts, including the City of Coos Bay, in the city's urban renewal districts.

Using input provided by the City Council's discussion February 19th, staff developed the following options to show what the Urban Renewal Advisory Committee could look like. The language designating the differences in the options is in *italics and underlined*. The Council may wish to establish the committee and then after a certain time period review the committee to see if Council's intent is being met.

Option 1

- (1) The Urban Renewal Advisory committee shall consist of up to seven voting members.
- (2) The members shall be appointed by the City Council to serve four-year terms except for members in office. Vacancies, except the regular expiration of a term, shall be filled by a temporary appointment made by the City Council for the remainder of the term.
- (3) All members shall be City residents. Members residing outside the City but who own property within the City are considered to have residential status. The Council may allow membership for one nonresident who possess subject matter expertise needed by the committee.
- (4) The membership shall be composed of one member of the Coos Bay Downtown Association, one member of the Empire Coalition, one member of the Eastside Neighborhood Committee, and <u>the four members shall be representatives of the overlapping taxing districts</u>.

Option 2

- (1) The Urban Renewal Advisory committee shall consist of up to seven voting members.
- (2) The members shall be appointed by the City Council to serve four-year terms except for members in office. Vacancies, except the regular expiration of a term, shall be filled by a temporary appointment made by the City Council for the remainder of the term.
- (3) All members shall be City residents. Members residing outside the City, but who own property within the City are considered to have residential status. The Council may allow membership for one nonresident who possess subject matter expertise needed by the committee.
- (4) The membership shall be composed of one member of the <u>Coos Bay Downtown Association</u>, <u>one member of the Empire Coalition</u>, <u>one member of the Eastside Neighborhood Committee</u>, <u>and four members shall be citizen-at-large positions</u>.

Option 3

- (1) The Urban Renewal Advisory committee shall consist of up to seven voting members.
- (2) The members shall be appointed by the City Council to serve four-year terms. Vacancies, except the regular expiration of a term, shall be filled by a temporary appointment made by the City Council for the remainder of the term.
- (3) All members shall be City residents. Members residing outside the City but who own property within the City are considered to have residential status. The Council may allow membership for one nonresident who possess subject matter expertise needed by the committee.
- (4) The membership shall be composed of citizen-at-large positions.

Option 4

- (1) The Urban Renewal Advisory committee shall consist of up to seven voting members.
- (2) The members shall be appointed by the City Council. Vacancies, except the regular expiration of a term, shall be filled by a temporary appointment made by the City Council for the remainder of the term.
- (3) All members shall be City residents. Members residing outside the City but who own property within the City are considered to have residential status. The Council may allow membership for one nonresident who possess subject matter expertise needed by the committee.
- (4) The membership shall be composed of <u>one member of the Planning Commission</u>, <u>one member of the Coos Bay Downtown Association</u>, <u>one member of the Empire Coalition</u>, <u>one member of the Eastside Neighborhood Committee</u>, and three members shall be citizen-at-large positions</u>.
- (5) <u>The Planning Commission, Coos Bay Downtown Association, Empire Coalition, and Eastside</u> <u>Neighborhood Committee members shall serve for one year. The citizen-at-large positions shall</u> <u>serve for three years.</u>

Take no action on forming the Urban Renewal Advisory Committee.

Encouraging citizen input and volunteerism in city government and the Urban Renewal Agency is listed as a top goal priority in the Council's 2013 Goals, and the creation of an Urban Renewal Advisory Committee to assist the Coos Bay Urban Renewal Agency is listed as one of the Council's short term activities aimed at achieving citizen input and volunteerism in city government.
