ISSUE NATIONAL TELECOMMUNICATIONS WEEK PROCLAMATION

BACKGROUND

Americans can show gratitude to 9-1-1 calltakers, dispatchers, and technicians that maintain radio and emergency phone systems, communications staff trainers, communications center personnel, and other public safety telecommunications staff across the country who work tirelessly, often behind the scenes, to help you during emergencies.

Proclamation

Whereas emergencies can occur at any time that require police, fire or emergency medical services; and

Whereas when an emergency occurs the prompt response of police officers, firefighters and paramedics is critical to the protection of life and preservation of property; and

Whereas the safety of our police officers and firefighters is dependent upon the quality and accuracy of information obtained from citizens who telephone the 9-1-1 / Dispatch Center at the Coos Bay Police Department; and

Whereas Public Safety Telecommunicators are the first and most critical contact our citizens have with emergency services; and

Whereas Public Safety Telecommunicators are the single vital link for our police officers and firefighters by monitoring their activities by radio, providing them information and insuring their safety; and

Whereas Public Safety Telecommunicators of the Coos Bay Police Department have contributed substantially to the apprehension of criminals, suppression of fires and treatment of patients; and

Whereas each telecommunicator has exhibited compassion, understanding and professionalism during the performance of their job in the past year;

Therefore Be It Resolved that I, Crystal Shoji, Mayor of the City of Coos Bay, hereby proclaim April 14 – 20 to be

in Coos Bay, in honor of the telecommunicators whose diligence and professionalism keep our city and citizens safe.
