ISSUE: OLCC License Application – 7 Devils Brewing Co, LLC

BACKGROUND:

Oregon Revised Statute (ORS) 471.166 establishes the process for local governments to make recommendations to OLCC regarding approval of or denial of initial OLCC license applications and any additional privileges to their existing OLCC license. As part of the process, the Police Department reviews all initial and additional privilege applications to ensure compliance with applicable regulations. The City Council is charged with the responsibility for recommending approval or denial of these applications to the Oregon Liquor Control Commission based on information submitted by the Police Department.

On December 18, 2012, Carmen Matthews owner of a new proposed brewery 7 Devils Brewing Co. applied for an OLCC license that would allow them to brew and sell beer at their business located at 245 South 2nd Street, Coos Bay.

Records Supervisor Chris Esperance has reviewed the application, conducted a records check of the business and applicants. The investigation revealed no information that would prohibit the issuance of the Limited On-Premises Sales OLCC license.
