ISSUE: Proposed Job Description changes for the Design Review Committee

# BACKGROUND:

The Design Review Committee was started to review design applications for the Empire Design Area. Since its inception, the duties of the Committee has expanded over time to additionally offer guidance on façade grants and advice on topics as the City Council directs. Over the past few months, the City Council Rules Committee to meet one of its 2014 goals has been meeting to redefine the role and responsibilities of the Design Review Committee. The major proposed changes are as follows:

- 1. Name change Design Review Committee to Design Assistance Team
- 2. Not required to meet for all Façade Grant and design review area projects/applications. They now can meet at pre-application conferences for all applications. Their comments will follow with the application as it is reviewed by the Planning Commission and/or City Council. The idea is to allow them to weigh in on a wider variety of applications while keeping them strictly an advisory group.
- 3. A maximum of two members who do not reside or own a business within the Coos Bay city limits may be appointed to the Design Assistance Team.
- 4. The Design Assistance Team shall undertake such other duties as may be delegated to it by the Director of Community Development or City Council from time to time.

Staff brought these proposed changes to the Design Review Committee (DRC) and Planning Commission (PC) for their initial comments. A summation of their comments are as follows:

- 1. Why this is being proposed when we have a very successful (DRC) with very talented people on it. Why are we trying to solve a problem when there isn't a problem?
- 2. The current (DRC) sections are written tighter and with more detail, particularly 2.40.303 and 2.40.040.
- 3. If one reason for the proposed change is to get the committee members involved earlier in the application process, why can't it just be added to the current section 2.04.040, and leave it as the successful (DRC) it has been for years now?
- 4. If very talented people are willing to give of their time as (DRC) volunteers, why do they have to reside or work in Coos Bay?

5. We should be thanking everyone on the current (DRC) for their time and talented contributions to the City of Coos Bay.

# **ADVANTAGES:**

- 1. The proposed changes would allow the Design Assistance Team (DAT) to be involved in a wider variety of projects at an earlier stage that they currently are.
- 2. The (DAT) could be involved in a wider variety of public projects than the current ordinance allows.

#### **DISADVANTAGES:**

(DAT) team members would be limited to two members who do not reside or own a business within the Coos Bay city limits. (This is could be seen as a positive or negative depending upon your point of view)

#### **BUDGET IMPLICATIONS:**

No implications on the budget at this time.

### 2.40.010 Purpose.

The purpose of this chapter is to establish a design assistance team (DAT) to act as an advisory body to the City of Coos Bay Community Development Department, Planning Commission, City Council and, if requested, the Urban Renewal Agency for the City of Coos Bay.

# 2.40.010 Purpose.

The purpose of this chapter is to establish a design review committee to act as an advisory body to the city of Coos Bay community services department, planning commission, city council and, if requested, the urban renewal agency for the city of Coos Bay.

# 2.40.020 Design assistance team – Creation – Membership.

(1) There is hereby created a design assistance team, which shall consist of up to seven members to be appointed by, and to serve at the pleasure of, the city council. Membership may include any person possessing interest in furthering the betterment of historic, cultural, architectural, natural or artistic resources in the Coos Bay area. A maximum of two members, who do not reside or own a business within the Coos Bay city limits, may be appointed to the design assistance team.

(2) Membership should, if possible, include three members, one each with knowledge and expertise in one of the following areas:

(a) Local history;(b) Art, graphics, or design;(c) Architecture.

(3) The city council shall review applications and interview applicants for appointment to the design assistance team.

(4) Terms of appointment shall be four years, and shall be staggered, with no more than four terms expiring in any one year. The initial appointment of four members shall be for three years; the initial appointment for three members shall be for two years.

(5) A vacancy created in the design assistance team shall be filled for the unexpired term of the predecessor in office.

#### 2.40.020 Design review committee - Creation - Membership.

(1) There is hereby created a design review committee, which shall consist of seven members to be appointed by, and to serve at the pleasure of, the city council. Membership shall not be limited to residents of the city of Coos Bay, and may include any person possessing interest in furthering the betterment of historic, cultural, architectural, natural or artistic resources in the Coos Bay area.

(2) Membership should, if possible, include three members, one each with knowledge and expertise in one of the following areas:

- (a) History;
- (b) Art, graphics, or interior design;
- (c) Architecture.

(3) The planning commission shall review applications and interview applicants for appointment to the design review committee, and make recommendations to the city council for appointments to fill vacant positions.

(4) Terms of appointment shall be three years, and shall be staggered, with no more than four terms expiring in any one year. The initial appointment of four members shall be for three years; the initial appointment for three members shall be for two years.

(5) A vacancy created in the design review committee shall be filled for the unexpired term of the predecessor in office.

### 2.40.030 Meetings – Rules – Procedure.

(1) The design assistance team are encouraged to, either individually or as a group, meet with and act as a resource for the city at land use pre-application conferences with applicants and city staff as scheduled by the community development department.

(2) Meetings and records of the design assistance team are subject to Oregon public meetings law and public records law; provided, however, that to the extent not inconsistent with state and local laws, the committee may make and alter rules and regulations for its proceedings and operation.

# 2.40.030 Meetings - Rules - Procedure.

(1) The design review committee shall hold such meetings as may be necessary to carry on the business of the committee. Meetings may be called by the chairperson, by any two members of the committee, or by the planning department, planning commission or city council.

(2) Meetings and records of the design review committee are subject to Oregon public meetings law and public records law; provided, however, that to the extent not inconsistent with state and local laws, the committee may make and alter rules and regulations for its proceedings and operation.

(3) The design review committee shall, at the first meeting of each fiscal year, elect a chairperson and vice-chairperson, who shall serve a term of one year. The chairperson shall preside over the meetings of the design review committee, and shall have a right to vote on any decision of the committee. The vice-chairperson shall preside over meetings in the chairperson's absence.

(4) Members of the design review committee shall receive no compensation for their service, but shall be reimbursed for duly authorized expenses.

(5) Three members of the design review committee shall constitute a quorum to do business.

#### 2.40.040 Powers and duties of the design assistance team.

(1) The design assistance team shall function as an advisory body in implementing and interpreting architectural design review, as set forth in the city of Coos Bay land development ordinance.

(2) The design assistance team shall cooperate with the community development department, planning commission, and city council, as well as other local bodies, to further the architectural design and to assure harmonious and integrated planning within Coos Bay.

(3) The design assistance team shall, upon referral by the planning department, planning commission or city council, review specific public and private proposals for consistency and compliance with the city's land development ordinance.

(4) In no instance shall the design assistance team's action conflict with the land development ordinance, the building codes, other applicable city ordinances, or state or federal requirements.

(5) The design assistance team may, individually or as a group, meet with and act as a resource for other persons or groups interested in undertaking projects which are directed at preserving historic, cultural, architectural, natural or artistic resources in the Coos Bay area, including those areas subject to the Coos Bay estuary management plan, but shall not, without prior approval by the city council, have the authority to endorse or officially support any particular project. This section shall not be interpreted to limit in any way the ability of a member of the design assistance

team from being employed in their professional capacity, including their ability to support their client and/or customer's particular project with the City.

(6) The design assistance team shall undertake such other duties as may be delegated to it by the *Director of Community Development* or City Council from time to time.

2.40.040 Powers and duties of the design review committee.

(1) The design review committee shall function as an advisory body in implementing and interpreting architectural design review, as set forth in the city of Coos Bay land development ordinance.

(2) The members of the design review committee shall become familiar with all aspects of architectural design review, and may prepare and recommend to the city council from time to time such changes in architectural design review which they deem in the best interests of the city.

(3) The design review committee shall cooperate with the planning department, planning commission, and city council, as well as other local bodies, to further the architectural design review process and to assure harmonious and integrated planning in areas subject to architectural design review in the city.

(4) The design review committee shall, upon referral by the planning department, planning commission or city council, review specific design proposals for consistency with and compliance with architectural design review as set forth in the city's land development ordinance.

(5) The design review committee shall, upon request by an applicant for a specific design proposal subject to architectural design review, meet with the applicant to review the proposal and provide the applicant with input for recommendations concerning and for compliance of the proposal with architectural design review goals and standards.

(6) Consultants or city staff involved with the design responsibility for publicly funded capital improvements in areas subject to architectural design review may hold preliminary discussions with the design review committee to obtain recommendations as to aesthetic, environmental and design principles and objectives which should be sought in the development of the improvement. The design review committee may also review the design of substantial capital improvements at the completion of the design development phase, or at any time, upon request by the city council, for compliance with and recommendations concerning architectural design review goals and standards.

(7) In no instance shall the design review committee's action conflict with the land development ordinance, the building codes, other applicable city ordinances, or state or federal requirements.

(8) The design review committee may meet with and act as a resource for other persons or groups interested in undertaking projects which are directed at preserving historic, cultural, architectural, natural or artistic resources in the Coos Bay area, including those areas subject to the Coos Bay estuary management plan, but shall not, without prior approval by the city council, have the authority to endorse or officially support any particular project.

(9) The design review committee shall undertake such other duties as may be delegated to it by the planning department, planning commission or city council from time to time.
