Public Hearing - Consideration of an Ordinance Regulating Smoking on City

Boardwalks and in City Pavilions

## **BACKGROUND**

At the May 6, 2014, Council meeting, City Councilors requested that staff bring forward an ordinance prohibiting smoking under the wooden pavilions at the north end of the City's wooden boardwalk. The City's current ordinance prohibiting smoking in Mingus Park can be amended to expand the smoking prohibition to these buildings. The current ordinance prohibiting smoking in Mingus Park was adopted by Council June 1, 2010 on a 4-3 vote.

The ordinance document attached for public hearing and your consideration adds language to the City's municipal code to prohibit smoking within twenty-five feet of the City's wooden boardwalk which would also include the City's three pavilions. The potential fine amount for violation of the proposed smoking ban is addressed by current language within the existing Parks Regulations (CBMC 12.35.030). A violation can result in a fine not to exceed \$1000. Police officers have flexibility in the way they might handle violations of the proposed smoking ban. The no smoking areas will be designated by signage.

#### **ADVANTAGES**

The public hearing will allow the Council to gather additional public input on this matter.

# **DISADVANTAGES**

Enforcement of the proposed ordinance is expected to impact Coos Bay Police Department resources; however the impact is expected to be limited.

#### BUDGET

There will be a cost for the purchase on installation of signage and poles for designated no smoking areas. Total cost is not expected to exceed \$2500 for materials. The signs will be installed by city staff. Funds for the materials will come from the Parks general fund.

### ORDINANCE NO. ###

AN ORDINANCE AMENDING ORDINANCE NO. 428, REGULATING ACTIVITIES AND USES WITHIN THE COOS BAY PARK SYSTEM

The City of Coos Bay ordains as follows:

**Section 1: Park Regulations, Smoking.** Section 2(15), "Park Regulations, Smoking, is hereby amended to read as follows:


**Section 2(15) Smoking.** No person shall smoke within the boundaries of Mingus Park which includes, but is not limited to the skateboard park, tennis court, basket ball court, softball/baseball area, Frisbee golf course, pool, play structures, gazebos, trails and paths, and the sidewalks on Commercial Ave and N 8<sup>th</sup> Street which abut the park. No person shall smoke within twenty-five (25) feet of designated play structures within any city park. In addition, no person shall smoke upon or within twenty-five (25) feet of the of the city's wooden boardwalk.

**Section 2:** This ordinance shall take effect 30 days after enactment by the Council and signature of the Mayor.

The foregoing ordinance was enacted by the City Council of the City of Coos Bay this 3rd day of June 2014.
