ISSUE: After the fact "Night Time Work"

BACKGROUND: Coos Bay North Bend Water Department applied for a permit with the City of Coos Bay to work in the right-of-way (ROW) which was approved. The scope of work on the permit indicated the work is schedule for day time operation, and included replacement of 1500 LF water main on Ocean Boulevard from Woodland Avenue to Water Board property. However, on 8/21/14 it was determine night time work would be required. City ordinance "Chapter 9.20" Offenses Against Public Peace", section 7 prevents excavation during the hours of; 6 pm and 7 am, unless approved by City Council. Coos Bay North Bend Water Department felt this work could not wait until September 2nd council meeting to present their request. In an effort to work with Coos Bay North Bend Water Department the City Manager authorized the nighttime work with the following requirement:

- Apply for permit at Public Works for "Night Time Work"
- Use portable light towers throughout the construction zone
- Submit Night Time Schedule with permit
- Present to the City of Coos Bay Council on Sept 2nd @ 7 pm "After the Fact Permit Reason"
- Permit will be revoke if the City determines activity adversely affects abutting neighborhoods
- PSA will be released to General Public one day prior to night time activity for each night time work occurrence
- "No Road Closures" on Ocean Blvd. Maintain minimum travel lanes east and west 12'
- Adjust your Traffic Control Plan if need to accommodate work to be done by the City from 19th to Woodland (Trimming of Hedge)

Right-of-Way Use Application for night work is attached. Laskey-Clifton will be performing the work. Their work schedule is shown below. They can confirm the schedule one week in advance as the time nears. We are asking for four separate work windows in Ocean Blvd:

Monday, Aug 25 at 7:00 pm through Tuesday, Aug 26 at 7:00 am

Water main installation in Ocean Blvd beginning at approx centerline extending easterly 300 ft

Wednesday, Sept 3 at 7:00 pm through Thursday, Sept 4 at 7:00 am

Pigging work. Pig entrance at Ocean Blvd/Woodland Dr intersection; pig exit at Ocean Blvd/Water Board driveway entrance

Wednesday, Sept 10 at 7:00 pm through Thursday, Sept 11 at 7:00 am

Water main installation crossing Ocean Blvd from approx centerline to Water Board driveway entrance, approx 100 ft.

Tuesday, Sept 16 at 7:00 pm through Wednesday, Sept 17 at 7:00 am

Two tie-ins of new water mains to existing water mains. One at Water Board driveway entrance on south side of Ocean Blvd. approx 20 ft. The other at Ocean Blvd centerline near Water Board driveway entrance, approx 40 ft.
