ISSUE Resolution 14-20 to accept the 2014 General Election Official Canvass of Votes

BACKGROUND

Section 6.4 of the City of Coos Bay City Charter requires the results of all elections be made a matter of record in the Council minutes and the official canvass as prepared by the Coos County Elections Department showing the votes for the election of the Mayor and City Council positions be accepted.

The November 4, 2014 election results were officially certified on November 21, 2014 by the Coos County Elections Office. In accordance with ORS 254.565 and 254.568 the City received the Official Canvass of Votes, prepared Certificates of Election, and on December 2, 2014 the oaths of office will be administered.

The fourth Council position was filled with a write-in candidate, Fred Brick, and the acceptance of nomination process has been completed. The oaths of office will be administered to Mayor Crystal Shoji and Councilors Jennifer Groth, Stephanie Kramer, Tom Leahy, and Fred Brick.

WHEREAS, the City Council of the City of Coos Bay called for an election on the 4th day of November 2014 for the purpose of election of the Mayor and City Councilor positions; and

NOW, THEREFORE, BE IT RESOLVED, that the attached abstract of votes upon the election of the Mayor and City Councilor positions, it appearing that the measure received the number of votes in the respective precincts as set forth in the official abstract, be entered into the official records of the City as required by City Charter.

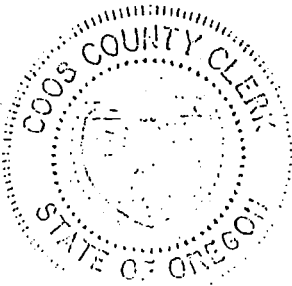

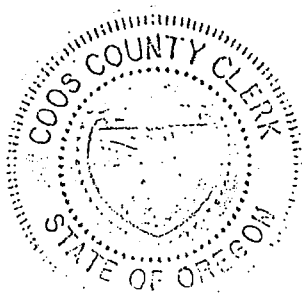
