ISSUE: Coos Bay Transit Station Grant Award

#### BACKGROUND

April 21, 2015 the City Council considered acceptance of a \$480,000 grant award for construction of a bus transfer station along 2<sup>nd</sup> Street in the public parking area. Staff presented parking lot survey results for the parking lots in the vicinity of the proposed transfer station. Several City Councilors expressed concern about what the loss of 25 parking spots to make way for the bus transfer station might have on the nearby businesses. Demand for the parking lot has increased since the grant application was first submitted in 2011. The Council raised questions about alternate locations for public parking as well as alternate locations for the transfer station.

In the attached map, City Staff has identified private parking areas within the downtown area along with two City owned properties, the old fire station site and the old Lockhart Building sites. More details are provided in the attached spreadsheet. Additional parking spaces, approximately 70 more, are available along City streets surrounding the proposed bus transfer station location. Staff will have weekend evening parking survey data for the public lots surrounding the proposed transfer station available at the Council meeting.

C-CAT loop schedule and services operates Monday through Friday only, there is no weekend service. Service in Coos Bay is generally between 8 a.m. and 5 p.m. for the loop, dial-a-ride, and connector service.

#### ADVANTAGES:

The new information will help the City Council formulate a decision regarding whether to accept the \$480,000 grant award.

#### **BUDGET IMPLICATIONS:**

The grant amount is \$480,000. The match includes \$90,062 for in-kind services which include city labor and equipment, demolition work, and site preparation. The match also includes the

City's property which is valued at \$54,938, for a combined match of \$145,000. The total project cost is \$625,000.

### **RELATED CITY GOAL:**



ODOT Rail and Public Transit Division is pleased to confirm an award of \$480,000 federal funds to the City of Coos Bay for completion of a bus transfer center on South 2<sup>nd</sup> Street between Anderson and Curtis Avenue. The bus transfer center is estimated to cost \$625,000 for the total project. The minimum cash match requirement for this award is 10.27% local funds of \$5'4,938 with estimated \$90,062 additional local resources for project completion. This project is funded with Federal Transit Administration (FTA) Rural Area Program funding and will be administered under FTA regulations. The City will be required to provide documentation to confirm eligibility under FTA requirements and will need to participate in the ODOT Rail and Public Transit electronic reporting system. The funds are scheduled to become available with execution of an intergovernmental grant agreement and notice to proceed.

Alison Wiley, Rail and Public Transit Regional Transit Coordinator (RTC), will be Contract Manager for this project. She will contact you to establish a "Statement of Work" and "Budget" for the project and work with you to coordinate documentation for FTA eligibility requirements and ODOT Rail & Public Transit Division reporting logistics.
