ISSUE Resolution 16-24 to accept the 2016 General Election Official Canvass of Votes

BACKGROUND:

Section 6.4 of the City of Coos Bay City Charter requires the results of all elections be made a matter of record in the Council minutes and the official canvass as prepared by the Coos County Elections Department accepted. The canvass documents the votes for the election of the Mayor and City Council positions and ballot measures. In accordance with ORS 254.565 and 254.568 the City received the Official Canvass of Votes and prepared the Certificates of Election. On November 15, 2016 the oaths of office were administered.

A RESOLUTION OF THE CITY OF COOS BAY, COOS COUNTY, OREGON ACCEPTING THE ELECTION RESULTS OF THE GENERAL ELECTION OF THE MAYOR AND CITY COUNCILOR POSITIONS; MARIJUANA TAX AND BUSINESS LICENSES; AND MOTOR FUEL TAX

WHEREAS, the City Council of the City of Coos Bay called for an election on the 8th day of November 2016 for the purpose of election of the Mayor and City Councilor positions; and

WHEREAS, the City Council of the City of Coos Bay called for an election on the 8th day of November 2016 for the electorate to consider ballot measures on marijuana tax and business licenses and a motor fuel tax; and

WHEREAS, it appearing to the City Council that the City Recorder gave notice thereof as required by the laws of the State of Oregon, and it further appearing that the County Clerk had prepared and arranged in the manner provided by law for the information on the ballot to be used in said election, and it further appearing that all of the requirements of the laws of the State of Oregon and of the Charter of the City of Coos Bay concerning said election were fully performed, and that said election was duly and legally held in said City; and

NOW, THEREFORE, BE IT RESOLVED, that the attached abstracts of votes upon the election of the Mayor and City Councilor positions; marijuana tax and business licenses; and motor fuel tax, it appearing that the measures received votes in the respective precincts as set forth in the official abstracts, be entered into the official records of the City as required by City Charter.

The foregoing resolution was duly adopted by the City of Coos Bay, Coos County, Oregon this 6th day of December 2016.

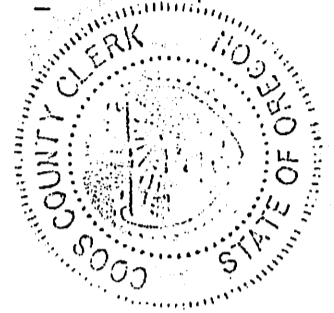

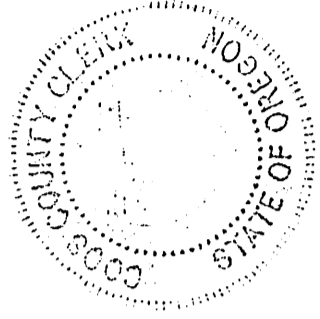

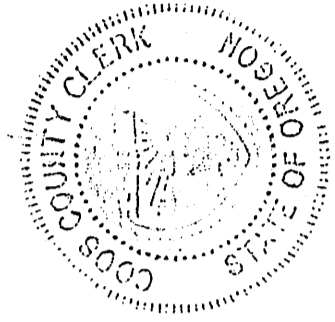
