<u>PARKS COMMISSION</u> – There are three openings, and we received applications from Beverly Meyers, Carmen Matthews, and Patty Scott, Geno Landrum, Darrick Betzenderfer, and Shaun Gibbs.

<u>COOS BAY/NORTH BEND WATER BOARD</u> – There is one opening, and we received applications from Melissa Cribbins and Roy Metzger.

#### **BACKGROUND**:

The City of Coos Bay has been seeking volunteers to fill positions on the Budget Committee, Design Assistance Team, Parks Commission, and Coos Bay/North Bend Water Board. The deadline for those openings was December 8<sup>th</sup>.

**Budget Committee** – Applicants must be a resident of the City of Coos Bay, and they are appointed by the City Council for three-year terms. The meetings are held in April at 7:00 p.m. **There are two openings and three applicants**. The openings were created by terms ending by Al Pettit and Philip Marler. Neither one qualify for re-appointment – Al Pettit moved to North Bend, and Philip Marler was appointed as City Councilor. The new applicants who would like to be considered for appointment are Melissa Cribbins, Curt Benward, and Darrick Betzenderfer.

**Design Assistance Team** – The Design Assistance Team acts as an advisory body to the City of Coos Bay Community Development Department, Planning Commission, City Council, and Urban Renewal Agency. Members may include any person possessing interest in furthering the betterment of historic, cultural, architectural, natural or artistic resources in the Coos Bay area. Applicants should have knowledge and expertise in one of the following areas: a) Local History; b) art, graphics, or interior design; c) architecture. Applicants should be a resident of the City, although the committee can have up to two members who reside outside of the City as long as they own property or a business within the City limits (Coos Bay Municipal Code 2.40.020). **There are three openings and two applicants.** The openings were created by Hilary Baker, Darla Lesan, and Perry St. John's terms ending. Hilary Baker would like to be considered for re-appointment and the new applicant who would like to be considered is Darrick Betzenderfer.

Parks Commission – Membership is comprised of one Councilor, one Planning Commissioner, one representative of a service club, one representative of the landscape design profession or business, one representative of the design profession, and three citizen-at-large positions. Applicants must be a resident of the City of Coos Bay or own property in the City. The Parks Commission meets once a month, although during winter months if there are no items to bring to the Commission, meetings are not held. All applicants must be Coos Bay residents (applicants who reside outside the City but who own property within the City shall be considered to have residential status) (Coos Bay Municipal Code 2.30.020). There are three openings (two citizen-at-large and one design professional) and five applicants. The openings were created terms ending by Beverly Meyers, Carmen

Matthews, and Patty Scott. Beverly Meyers, Carmen Matthews, and Patty Scott would like to be considered for re-appointment, and the new applicants Geno Landrum and Darrick Betzenderfer would like to be considered for appointment.

Coos Bay-North Bend Water Board – Applicants must be a resident of the City of Coos Bay for a period of not less than one year prior to appointment. Board meetings are held once a month at 7:00 a.m. at the Water Board office. Appointments are for four years. There is one opening and two applicants. The opening was created by Melissa Cribbins' term ending. Melissa Cribbins would like to be considered for re-appointment, and the new applicant Roy Metzger would like to be considered for appointment.

The City of Coos Bay is also seeking volunteers to fill positions on the **Library Board** and the **Planning Commission**. The deadline for applying for these openings is by 5:00 p.m. **December 23, 2016**.

**Library Board** - The Library Board, consists of seven members. The term of office is four years; up to three board members may at any one time reside in Coos County within the boundaries of School Dist. 9, but outside the city limits of Coos Bay. Members shall be limited to serving no more than two full consecutive terms; however, any person may be reappointed after an interval of one year. **There is one opening and two applications**. The opening was created by Drew Farmer due to his election as City Councilor. The new applicants who would like to be consideration for appointment is Darrick Betzenderfer and Curt Benward.

**Planning Commission** - The Planning Commission functions primarily as a comprehensive planning body by proposing policy and legislation to the city council and by implementing regulations relating to the growth and development of the community. The Planning Commission is a seven-member citizen advisory board appointed by the City Council. It is the decision-making authority for many land use applications. It also makes recommendations to the City Council on land use planning issues. Applicants must be a resident of the City of Coos Bay for a period of not less than one year prior to appointment. **There is one opening and one application.** The opening was created by Philip Marler due to his appointment as City Councilor. The new applicant who would like to be consideration for appointment is Chris Hood.

Over the course of the City's history, there has been two methods of determining appointments to the committees. One was to receive applications and determine appointments, and the other option was to conduct interviews. If you decide to conduct interviews, staff will need to schedule the interviews sometime prior to the next City Council meeting for the Budget Committee, Design Assistance Team, Parks Commission, and the CB/NB Water Board.
