Review of the Following Council/URA Agenda for December 5, 2017

Review / Update of the Empire Urban Renewal Plan

The Agency's Urban Renewal Consultants, Elaine Howard and Scott Vanden Bos, reviewed the current Plan which included a discussion on established goals and projects as well as what was accomplished to date. Elaine Howard will provide the calculation on how much the maximum indebtedness could be increased without starting a new plan. Mr. Vanden Bos stated the original plan was adopted August 1995 with an original maximum indebtedness of \$12,550,011 and listed categories of projects, summarized as follows:

Primary Commercial Area: Create a distinct identity or theme, improve the physical and visual environment; provide pedestrian linkages; provide adequate parking; redevelop key properties, and assist businesses with improving their building.

Waterfront Area: Provide pedestrian walkway; improve the boat ramp; provide additional public open space; and develop interpretive structures.

Empire Blvd and Bayfront: Coordinate with Oregon Department of Transportation (ODOT), provide a viewing platform, restrooms, and interpretive structures.

General Commercial and Residential Areas: Where necessary, construct replace utility systems; abate blight; develop or redevelop vacant and underutilized property; provide pavement, curbs, and sidewalks, identify location where small parks or open spaces could be developed, and establish a low interest revolving loan fund for housing rehabilitation.

General District Objectives: Replace and repair utility systems; replace and build new streets, curbs, sidewalks, bike lanes, and street lighting fixtures; develop or redevelop vacant and underutilized property for resale or redevelopment.

Assistance to Dolphin Theatre Association

Financial capacity:

Five year growth rate = 2.78% Eight year growth rate = 2.83% \$800,000 du jour financing FYE 18 budget = \$1,256,000

Capacity to borrow of \$6,000,000, 3% interest, 20 year term

Potential new project could be the Library land purchase, demo of existing structures, and possible grant assistance (\$1 - \$1.25 million), Hollering Place (\$1.2 million), and public safety (police/fire substation in the new Library), facade program (\$50,000 per year for 10 years), and Street projects. Discussion ensued on seeking public input on the project list and the process to extend the plan. Anticipated a public meeting in January to provide time for the Agency to view the street conditions and to prepare for a second meeting in February to make final decisions.
