August 27, 2019

The minutes of the proceedings of a special meeting of the City Council of the City of Coos Bay, Coos County, Oregon, held at 6:00 pm in the Council Chambers, 500 Central Avenue, Coos Bay, Oregon.

Mayor Benetti opened the meeting and led the Council and assembly in the salute to the flag.

Mayor Benetti removed the consent calendar from the meeting agenda.

<u>Public Hearing on Land Use Application #187-18-000153 - Jordan Cove Energy Project Navigation and Efficiency and Reliability of the Coos Bay Deep Draft Navigation Channel</u>

Mayor Benetti stated Jordan Cove Energy Project (JCEP) seeks to dredge at four locations in the Coos Bay Deep Draft Navigation Channel. One of the four locations (area 4) is in Coos Bay's land use jurisdiction area. JCEP application 187-18-000153 proposes the following amendments to the city's comprehensive plan and land use permits to enable the dredging of area 4:

- (1) A map amendment to the Coos Bay Estuary Management Plan and zoning map to change the designation of approximately 3.3 acres from 52-NA to DDNC-DA;
- (2) A text amendment to the City of Coos Bay Comprehensive Plan to take a reasons exception to Statewide Planning Goal 16 Estuarine Resources to authorize the map amendment:

- (3) An estuarine and coastal shoreline uses and activities permit for "New and Maintenance Dredging" in the DDNC-DA Estuarine Zone; and
- (4) An estuarine and coastal shoreline uses and activities permit to allow an accessory temporary dredge transport pipeline in the 52-NA, 53-CA, 54-DA, and 55-CA Estuarine Zones.

Mayor Benetti read rules and procedures for the Land Use Hearing. Mr. Benetti established all the members of the City Council were able to hear the matter in a fair and objective manner having no ex parte contacts; read conflict statements with no Council affirmations, no objections were made for any Councilor participation in the hearing, and stated the City Council was qualified to proceed with the hearing.

The City engaged, at the applicant's expense, professional planning staff from the Lane Council of Governments (LCOG) to process this land use application. LCOG's agenda item summary and staff report provide an expansive analysis of the application relative to Oregon planning law and the City's comprehensive plan and development regulations. The Planning Commission reviewed the application and recommended Council approve with conditions the Land Use application #187-18-000153. LCOG Principal Planner Jacob Callister requested deliberations and decisions be delayed to allow LCOG to review the information and testimony received August 27, 2019. LCOG Assistant Planner Henry Hearley read the names for testimony received August 27, 2019. Mr. Callister reviewed the process timeline, key criteria and parameters, and Council action motion alternatives. An ordinance and formal finding of fact would be needed upon decision.
