TWO THUMBS (OR THREE) UP FOR THE MEN AND WOMEN IN BLUE — Our police personnel have responded to nearly 8,000 calls for service so far this year. They are doing a great job! Below you will find a few highlights from recent events:



THIEF SENTENCED TO TEN YEARS - Sergeants Robert Lounsbury and Hugo Hatzel along with Officers Tony Wetmore, Chris Krebs, and Brian Looney, each working separate investigations, gathered evidence identifying Daniel Robert Taylor as a person involved in a number of recent burglaries, thefts, unlawful use of credit cards, etc. With the mountain of evidence against him, Mr. Taylor plead guilty earlier this week, and he was sentenced to ten years in prison.



**\$10,000 OF STOLEN PROPERTY RECEIVED** - Officers Brian Looney, Tim West, and Tom Lindahl responded to a burglary on June 28<sup>th</sup> where they learned that a large amount of property had been stolen. The insuring investigation lead officers to a location near the scene of the burglary where they located and recovered over \$10,000 in stolen property. While the investigation is continuing, the property has been returned to the rightful owners.



MURDER SUSPECTS APPREHENDED - In the early morning hours of June 27<sup>th</sup>, officers responded to the scene of an apparent homicide. Within 12 hours, two suspects were identified and taken into custody. Way to go Sergeant Mike Shaffer, Detectives Ken Labrousse and Mark Wheeling, Officers Pete Kirk, Tim West, Steve Myers, Mark Ereth, Tom Lindahl, Brian Looney, Reserve Officers Luke McGriff and Jordan Moeller, and Dispatcher Jennifer Pickett. The City also appreciates the invaluable assistance we received from the interagency Major Crimes Team.

<u>COMMUNITY ENHANCEMENT PLAN OPEN HOUSES JULY 9<sup>TH</sup> – 11<sup>TH</sup> - The Community Enhancement Plan (CEP) Work Group will hold three Open House sessions to answer questions and hear feedback from citizens as follows:</u>

Thursday, July 9<sup>th</sup>, 6pm-8pm, Blossom Gulch Elementary School Cafeteria, Coos Bay Friday, July 10<sup>th</sup>, 11am-1pm, The Barn in Bandon City Park, Bandon Saturday, July 11<sup>th</sup>, 10am-12pm, Oaks Pavilion at Coos County Fairgrounds, Myrtle Point

The Community Enhancement Plan is the result of community discussions regarding the property tax implications of the Jordan Cove Energy Project and its participation in the State of Oregon's Enterprise Zone Program.

Representatives from the South Coast Community Foundation, the Waterfront Development Partnership, and the CEP Work Group will be available to discuss their plans with attendees. Handouts summarizing the activities of these three entities will also be provided to the public.

The format of these meetings allows citizens to discuss issues with elected officials and staff on a one-on-one basis. Citizens interested in providing public testimony

will be able to do so when the governing bodies meet at a later date to hold public hearings on these proposals.

All meeting minutes, handouts, and draft agreements related to the Community Enhancement Plan are available on the Port of Coos Bay's website.

The Community Enhancement Plan Work Group will meet next on Monday, July 20<sup>th</sup> at 1:00 pm in the Coos Bay City Council Chambers to review citizen feedback. The next step will be to present the CEP to the governing bodies for approval including the City of Coos Bay, the City of North Bend, Coos County, and the Oregon International Port of Coos Bay.

### POTHOLES AND ROUGH STREETS IN COOS BAY! - What's going on? The



City Council heard you. As the City of Coos Bay lacks the resources to fix our roads, the Council created a Streets Task Force to explore the problems and to make recommendations to the City Council on the management and financing of street maintenance. The Task Force consists of local

residents, business owners, and local subject matter experts. One of the recommendations from the Task Force was to update the City's Street Conditions Assessment. The updated assessment has been completed. The assessment report will be presented to and discussed by the City Council during the July 7, 2015 City Council meeting which begins in the City Hall Council Chambers at 7:00 p.m.

The Street Task Force also considered funding options for street maintenance/repair to recommend to the City Council. The Task Force recommends the City Council consider increasing the PacifiCorp franchise fee an additional 2% to cover the City's current cost for streetlight and traffic signal expenses (nearly \$290,000 annually). This in turn will free up the Gas Tax funds that currently pay those expenses to be used for street maintenance/repairs. The Coos Bay City Council will consider raising the franchise fee at the July 7<sup>th</sup> meeting. Additionally the Task Force recommends the Council consider implementing a \$0.05/gallon local fuel tax. This would provide additional revenue for street maintenance/repair and would be paid by local and out-of-town users of the City's street system. The City of North Bend has already approved raising the PacifiCorp franchise fee, and they are also considering the local fuel tax. Implementing a local fuel tax requires voter approval. Over the next few months, you will be hearing the "whys" and "wherefores" about a local fuel tax.
