CITY PURCHASES DOWNTOWN PROPERTY — Under direction from the Coos Bay Urban Renewal Agency, yesterday city manager Bill Grile and Urban Renewal chair Joe Benetti signed documents transferring ownership of downtown property known commonly as "The Sportsman" to city ownership at a negotiated price of just under \$174,000. "The City's plan is to demolish the building and open the area up to make the walkway from Broadway to the parking lots behind The Egyptian Theater more like a plaza and open space," said city manager Bill Grile this morning. This action is part of the City's ongoing efforts to improve the livability of downtown and improve the commercial core. Details will follow.

CHAMBER OF COMMERCE PONDERS 2001 GOALS — City manager Bill Grile spent the better part of yesterday in Bandon at a retreat with Chamber president-elect Greg Stevens and other community business and government leaders pondering goals for the Chamber for 2001. Ideas were refined concerning membership development, economic development, transportation, tourism and other key areas of community concern. Present and participating in the discussion was Carol LeTellier, new executive director for the Chamber. Stay tuned for an exciting new year.

PLANNING COMMISSION ACTION / MEASURE 7 — After months of public hearings and workshops, Tuesday evening the Coos Bay Planning Commission recommended approval to the City Council for architectural goals and design standards for the portion of the Empire district abutting Newmark, extending from the intersection Ocean Boulevard to Empire Boulevard. In addition, the Commission recommended approval to the City Council for the comprehensive plan amendments, zone change and architectural goals and design standards for the North Front Street area to enable redevelopment which would allow a mix of commercial and residential uses in addition to water-dependent uses.

2001 NEEDS AND ISSUES INVENTORY – The City has completed and submitted the 2001 Needs and Issues Inventory to CCD Business Development Corp this week. The inventory is anticipated to facilitate the creation/reorganization of county wide priority lists which are coordinated by the Regional Coordinating Organizations serving local and regional areas throughout the state. CCD Business Development Corp is coordinating the process in Coos and Curry county. The inventory does not guarantee funding, however state and federal agencies draw from this inventory to further develop the projects listed and to invite applications for funding.

<u>HO! HO! HO!</u> – Santa's coming to town! The Downtown Association invites the community to attend the City's annual tree lighting ceremony on Friday, November 24th. The event will be held at the Convention Center located at 158 Central Avenue and will begin at 6 p.m. There will be entertainment, caroling, refreshments, and pictures with Santa and cookie decorating for the children. Santa will arrive by horse-drawn carriage at 6:30 p.m. and carriage rides will be offered throughout the evening.
