CITY OF COOS BAY PREVAILS IN COURT CHALLENGE OF DEQ CIVIL PENALTY

ASSESSMENT – The Oregon Court of Appeals ruled this week that the Oregon Dept. of Environmental Quality improperly assessed a civil penalty against the City of Coos Bay arising out of a 1995 sewer line break in Eastside. "I knew I was right," quipped City Attorney C. Randall Tosh from City Hall this morning. DEQ felt that it somehow had the authority to require a permit prior to an accidental unanticipated break in the sewer line. Huh? The Court of Appeals ruled that the statute at issue specified when it is necessary to obtain a permit while another section of the code provide for violations of the program. In fairness, it needs to be said that the City did pay two other small civil assessments totaling about \$1500 related to the incident.

NATIONAL LEAGUE OF CITIES REPORT DOCUMENTS THE IMPORTANCE OF TOURISM AND ENTERTAINMENT TO LOCAL ECONOMIC DEVELOPMENT — A National League of Cities survey of 463 cities has produced statistics documenting the importance of tourism and entertainment to local economic development by revealing that city leaders across the country rank these features as important as trade and manufacturing as sectors that fuel local economic engines. Historic districts, museums and farmer's markets were mentioned by more than half the survey respondents as critical components of healthy local economies, according to the study.

"This shows we're heading in the right direction with plans underway to help improve our downtown commercial core," said city manager Bill Grile this week. "With a regional art museum already in place and a major historical museum on the way, and with the success of this summer's farmer's market added to the Old Marshfield Historic District designation, it becomes clear that we need to simply continue doing what has already begun to achieve the success we seek," he added. <u>CHAMBER ECONOMIC DEVELOPMENT COMMITTEE CONTEMPLATES ISSUES</u> – The Committee met last Monday and reviewed a number of pending issues, including the relationship between the committee and the South Coast Development Council (SCDC). Promoting two-way communication between the Council and the Chamber, helping dispel pessimism in the community and setting a positive tone for economic development efforts are among the Committee's objectives.

Southwestern Business Development Center director Jon Richards briefed the committee about an application being submitted through Guy Alvis / OECDD to improve Verizon's connectivity with route enhancements through extending the existing interconnection to the Qwest network at Winston westward through Camas Valley, Myrtle Point, Coquille, and Bandon to Coos Bay and north through North Bend, Lakeside, and Reedsport to a new interconnection with Qwest at Florence. Upgrade of the Qwest network utilizing SB 622 funds will enable the development of route diversity in this portion of the Verizon Network. The grant request is for \$300,000.
