SOUTH COAST TELECOMMUNICATIONS MEETING DRAWS INTERESTED CROWD - About thirtypeople met this morning at Southwestern Oregon Community College's Newmark Center to hear an update from the Oregon Economic and Community Development Department about fiber-optic telecommunications in the state and progress underway to bring the benefits of technology to the South Coast. Kudos to Lori Capps and Jon Richards with Southwestern's Business Development Center for arranging the meeting. OECDD's Link Shadley gave an excellent PowerPoint presentation about the state of telecommunications in Oregon. FIRE CHIEF SERVES ON INTERNATIONAL COMMITTEE - Fire Chief Stan Gibson attended the 78th Annual International Fire Service Training Association Conference in Tulsa, OK last week. Chief Gibson served on the review committee for the training manual, "Fire Service Hose Practices". Other committee members represented fire departments from throughout the nation. The committee will spend the next year updating the material and photos in the current edition of the manual. The manual was last updated in 1987. These manuals are used by the fire service throughout the world, translated into five foreign languages, and are based on the international training standards.

<u>LIBRARY OFFERS "SEARCH ENGINE BASICS"</u> - Coos Bay Public Library reference staff will offer the third in a series of basic computer workshops on Tuesday, July 31st, from 5:30 to 6:30 p.m. in the library's Myrtlewood Meeting Room. The session will describe different types of Internet search engines, demonstrate how to find specific information on the Internet, and give special tips on using some popular search engines. The workshop is free, and no registration is required.

ART SHOW TO OPEN AT THE LIBRARY - Well-known artist Maggie Karl will open an exhibit of her work at the library on Tuesday, July 31st. She will show watercolors, oils, collages, and "stained paintings." The latter is a technique, according to Karl, where you "drip and pour - and pray - on raw canvas." Karl was active in the Coos Artist League when it became the Coos Art Museum in 1966. She became the museum's director in 1970 and continued until 1981. She is living and working in Bandon after a 17-year stay in Santa Fe.

MARIONETTE SHOW SCHEDULED AT THE LIBRARY - The popular Celeste Rose will present two performances of her marionette show, "The Story of Jumper the Pony," on Thursday, August 2nd at 11:00 a.m. and 6:30 p.m in the Myrtlewood Meeting Room. The 45-minute program, an original story by Rose, is free of charge and open to children of all ages. It is part of the library's summer reading program. Rose is the director of the Oregon Fantasy Theatre and has appeared many times at the library.

LABOR TRENDS Nonfarm Jobs Rise on South Coast in May - Nonfarm employment in Coos County rose by 300 in May. This was about on par for this time of the year. The seasonally adjusted payroll job index inched upward by 0.1 percent. Over the year, nonfarm jobs were higher by 170 (+0.7%). Coos County's manufacturing sector expanded by 110 jobs in May. The increase was split about evenly between the wood products and food products industries. Coincidentally, however, manufacturing jobs fell by 110 over the year, with most of that loss, 80 jobs, coming in the wood product industry, primarily in logging and sawmills. Miscellaneous nondurable goods was down by 30, as well. Nonmanufacturing jobs in Coos County expanded by nearly 200 in July. Public education, service, and construction had the largest gains. Over the year, nonmanufacturing jobs advanced by 280, a gain of 1.5 percent. Jobs in services increased by 230 over the year, while retail trade gained 110, and local government expanded by 80, most of that involving tribal activities. <u>CITY GETS REDUCED ASPHALT PRICE</u> - The City is able to purchase asphalt at a reduced rate through Bracelin and Yeager this year due to a State purchasing agreement. If a government agency belongs to State Purchasing Pool they are able to buy equipment and tools that the State has already received bids on. The new asphalt price will result in a three dollar savings per ton. The annual savings to the City will be

about \$2,100.

LEAGUE OF OREGON CITIES AND TRI-MET JOIN TO HELP SMALL CITIES - The City of Coos Bay is signing an agreement with the League of Oregon Cities to exchange our federal Surface Transportation Plan funds with local funds from Tri-Met. The exchange allows the City to follow local contracting rules for the funds instead of federal rules. This year the City's allocation of federal funds is \$87,126. Because of the extensive administrative requirements of managing a project that uses federal funds, and the small amount of money available, up to 50% of those funds would have been used up by following the federal contracting guidelines. Historically, ODOT had exchanged these funds for us at a cost of 6%. However, ODOT discontinued the program this year and small communities were left scrambling for options. Tri-Met stepped up to the plate and said it could exchange funds for many small cities and counties, for an 8% exchange rate. The League of Oregon Cities brokered the deal for the funds exchange and also was instrumental in assisting with the passage of legislation that should allow the ODOT fund exchange program to be reinstated next year. The \$80,156 the City will receive will be used for street overlay projects next spring or early summer.

SNOWY PLOVER UPDATE - An informational meeting was conducted in Coos Bay recently by the Oregon Parks and Recreation Department to gather public comments surrounding current snowy plover beach closures. The first of several meetings, OPRD presented the big picture of beach planning efforts scheduled over the next several years. Of the 17.3 Oregon beach miles set aside for protection of the snowy plover, 2.8 miles lie within Coos County. The rare species, which nests on the beach between the low tide line and the vegetation line, was listed by the Federal government as endangered in 1993. At last count, there are approximately 90 pairs of the bird in Oregon. Although the Oregon Department of Fish and Wildlife and the Federal Bureau of Land Management play a part in the plover's plight, it is the OPRD who is charged with the protection and preservation of the recreation, scenic, natural, and other resource values found on the Oregon coast. Regulated activities range from public beach access and camping to construction projects such as pipeline routing. Peter Kirk, of the Department of Community Services Engineering Technician, attended the meeting on the City's behalf and reported that although tourism could be impacted, none of the beach closure areas are in the Coos Bay city limits.

PERIODIC REVIEW/COOS BAY ESTUARY MANAGEMENT PLAN: The Planning Commission has scheduled a work session for August 2nd at 6 p.m. at City Hall to review and discuss changes to the Plan. The changes are in response to amendments that have occurred to Statewide Planning Goals #16 (Estuarine Resources) and #17 (Coastal Shorelands). New uses and definitions have been added.
