METH. NOT HERE. NOT NOW. NOT ANYMORE... - Methamphetamine; an ugly drug; even uglier facts: Coos County has one of the highest incidences of meth abuse in the USA. Someone who knows what to buy can build a meth lab with simple materials that cost just \$77 in local hardware and grocery stores. Meth makes users crazy. Sometimes when it is sold it is mixed with rat poison; some users die. Users hallucinate and think they have bugs crawling out of their skin. They steal and sell the drug to support their habit. Meth users physically abuse and neglect their children. Meth abuse drains 11.6 million dollars from health care resources in the Bay Area alone, every year. There are not adequate enforcement resources here. The money's not there. There are not adequate treatment facilities here. The money's not there, either. Users often go to jail for a few days, then back on the street. Back to your neighborhood. And back to meth. You live here. What are you going to do about it?

CONFEDERATED TRIBES PARTICIPATE IN GOVERNMENT CHANNEL - Tuesday night Tribal Chair Carolyn Slyter presented the City Council with a check for \$7500 as support for Channel 14, Coos Bay's government access television channel. The subscription covers the remainder of the current fiscal year (through June 30th) and also covers next fiscal year. The Confederated Tribes are this year's strongest subscriber-partner helping bring government television programming to South Coast viewers. The City is excited to have the Confederated Tribes of Coos, Lower Umpqua and Siuslaw Indians participate in the government channel and is looking forward to continuing with building the City's relationship with the Tribal Council. THE ENERGY CRISIS – WHY IT CAN'T HAPPEN HERE - The Chamber of Commerce lunch forum on February 21st will feature Pacific Power and Northwest Natural Gas. The public is invited to attend the forum to learn about how deregulation in Oregon differs from California, what you can do now, how to prepare for deregulation, the natural gas update and more. FIRE DEPARTMENT 2000 STATS - The Fire Department responded to a total of 1,494 incidents in the year 2000, up from 1,415 in 1999 and 1,362 in 1998. Of the 1,494 incidents responded to 62 percent were medical related calls.

FIRE DAMAGES RED LION INN - At approximately 12:30 on Monday afternoon a Red Lion Inn employee discovered a fire in the main building of the hotel. The fire originated in a storage room in the main building and was quickly extinguished by fire crews. Nobody was injured, but not before significant damage was done. A damage estimate of \$40,000 to \$50,000 will likely keep the restaurant, lounge and Terry Travel closed for a time to allow for repairs and cleanup. The cause of the fire is still under investigation.

<u>VISION 2001 HIGH SCHOOL ART COMPETITION</u> - Winners of the Vision 2001 competition sponsored by the Coos Art Museum and Southwestern Oregon Community College were recently announced. The sixth annual high school art competition was open to high school students on the south coast from Reedsport to Brookings. The winners represent five high schools and include:

<u>TNT MARKET SIGN APPROVED</u> - At the hearing on Tuesday evening, the City Council approved a reader-board sign for the TNT Market in Eastside. Problems arose with the placement of the sign because the market, a commercial use, is located in the Multiple Residential zoning district. As explained by Roger Gould, representing TNT Market, the market has been there for over 80 years and was zoned commercial before Eastside merged with the City of Coos Bay.

COMMUNITY HEALTH ALERT - The OSU Extension Service and Coos County Health Department are joining forces in presenting *Skills for a Healthier Life*, a presentation entitled "Removing Rats, Rodents & Risks." Two sessions are planned for February 13, 2001 on the South Western Oregon Community College campus - 2 p.m. at Empire Hall, Room #104, and 7 p.m. at Eden Hall, Room #1. Guest speakers Emilio DeBess, from the Oregon Health Division, and David Ottovich, of Swanson Pest Control, will cover topics which include rodent related food contamination and home risk reduction. DO YOU NEED A BUSINESS LICENSE? - "All trades, shops, businesses, occupations, professions, and callings carried on in the City and not licensed and taxed by other provisions of this or other ordinances of the City, shall be licensed and the amount to be paid as license fees..." (Coos Bay Ordinance No. 103, Section 7 (1)) This includes all businesses from grocery stores to hair stylists to architects. City staff is in the process of reviewing County records against the current City business license listing to ensure that all businesses receive their renewal applications for 2001. The 2001 licenses were due by January 31st and late fees apply after that date. If you haven't received a renewal notice, have never had a license, or if you have any questions, give us a call at 269-8918.

THE "ANDERSON ALTERNATIVE" MAY KEEP RITE AID DOWNTOWN SAYS COMPANY OFFICIAL - Nissa McPherson, a Rite-Aid Pharmacy Technician attended the City Council meeting this week with Jay Noggle, Downtown Association President. Nissa came representing the Rite Aid Corporation and requested that the City move forward with the Anderson Alternative, a traffic pattern change that would provide two-way traffic on Anderson from Bayshore to 2nd Street. Nissa indicated that Rite Aid Corporation is looking at sites along Hwy 101 to increase traffic, but that staff would prefer to stay in downtown where they can continue to be easily accessible to the population living in the downtown core. However, she went on, the Anderson Alternative and two-way traffic to 2nd Street in order to increase traffic and have better access to parking is critical to the Corporation decision to remain in Downtown Coos Bay. A letter from Doug Fletcher of Fletcher Enterprises supporting the Alternative was also presented. The City Council is seeking additional input from Downtown Association members and others. HISTORIC MUSEUM MOVING FORWARD - Historic Society members attended the City Council meeting on February 6 to present a final site location request for the Historic Museum. The original agreement between the City and Historic Society did not indicate a final location so that a preliminary design could be completed. The final location approved by the Council is just north of Central between Bayshore and Broadway. The site is approximately 15,000 square feet and includes enough space so that a "plaza" feel can be obtained. The Historic Society and City will work together to design the Central Ave. pedestrian space between Bayshore and Broadway to encourage visitors to move between the waterfront and downtown and to stay awhile in Coos Bay! The Historic Society also introduced Doug Fletcher as the person who will be responsible for their fund raising activities.

MOVING FORWARD ON A BAY AREA SKATEPARK - Energy is returning to the mission to create a new, bigger and better skatepark. The Coos Bay City Council continues to be very supportive of this project. Community Services Director Shanda Shribbs attended the monthly meeting of the Bay Area Skate and Bike Association this week to discuss options for moving forward. Several new options for locations and funding sources are being considered and studied by city staff AND by parents and skatepark users. SPORTSMAN PLAZA - The Urban Renewal Agency acted this week to direct staff to proceed with assisting with the relocation of the businesses occupying the Sportsman Building and to go out for bid for demolition of the building and creation of a pedestrian walkway through the site between Broadway and 2nd Court. The area will have the same period lighting as currently exists on Broadway and in the city's parking lots at 2nd Court and Curtis. Other plantings and benches will also be included. EMPIRE GATEWAY MONUMENTS - In other action this week, the Urban Renewal Agency voted to ask the Design Review Board to look again at the option of roadside monuments to designate the entrances to the Empire Area. Agency Member Joe Benetti requested that the Agency revive the drawings originally completed by Architect Richard Turi and ask the Design Review Board to make a recommendation to the Agency. The action was unanimously supported by the entire Urban Renewal Agency.

THINGS ARE HAPPENING IN DOWNTOWN COOS BAY! - At Tuesday's Council Meeting, the City Council approved the liquor license for the Coos Bay Elks Lodge BPOE #1160. The Elks will be moving to 265 Central in the near future. Also "Happening" is a new business to downtown Coos Bay! The Pottery Company will be opening its doors any day now. The Pottery Company is moving from the Pony Village Mall. Welcome to Coos Bay!

SKATEBOARD PARK DAMAGED - Earlier this week two persons were charged by Coos Bay Police with Criminal Mischief at the Coos Bay Skateboard Park. In addition to the criminal mischief charges four thirty day suspensions were issued to four youths. The damage comes at a time when the city is looking at ways to make enhancements to the park for the benefit of the youth in Coos Bay.
