During this year's annual City goal setting, the City Council identified "encouraging citizen input and volunteerism in city government" as one of their top priorities and "creation of an Urban Renewal Advisory Committee" was selected as one of the Council's short term activities aimed at reaching the aforementioned priority.

The intent of urban renewal is to improve specific areas of a city that are poorly developed or underdeveloped, eliminate 'blighting' conditions and improve conditions to encourage economic development. The City of Coos Bay has two urban renewal districts: the Downtown District established in 1988 and the Empire District established in 1995. The City Council also serves as the Urban Renewal Agency Board and the city manager reports to both the Council and the Agency.

The City Council established the Urban Renewal Advisory Committee March 5, 2013 to serve in an advisory capacity to the Urban Renewal Agency. The scope of responsibilities includes, but is not limited to, review of the annual proposed budget, review and recommendations on current and future projects, long range planning, proposed plan amendments and other matters as requested by the Agency. It is anticipated the committee will meet frequently in the beginning and as needed thereafter.

### Criteria of the Urban Renewal Advisory Committee

- The Urban Renewal Advisory committee shall consist of up to seven voting members.
- The members shall be appointed by the City Council. Vacancies, except the regular expiration of a term, shall be filled by a temporary appointment made by the City Council for the remainder of the term.
- All members shall be City residents. Members residing outside the City, but who own property within the City are considered to have residential status. The Council may allow membership for one nonresident who possess subject matter expertise needed by the committee.
- The membership shall be composed of one member of the Planning Commission, one member of the Coos Bay Downtown Association, one member of the Community Coalition of Empire, one member of the Eastside Neighborhood Committee, and three members shall be citizen-at-large positions.
- The Planning Commission, Coos Bay Downtown Association, Community Coalition of Empire, and Eastside Neighborhood Committee members shall serve for one year. The citizen-at-large positions shall serve for three years.
