Consent Calendar

Chair Kramer reviewed the consent calendar which consisted of:

<u>Presentation on the City of Coos Bay Urban Renewal Agency Audit for the Fiscal</u> <u>Year Ending 2017</u>

Finance Director Susanne Baker reminded the Agency that due to unforeseen circumstances, Senior Auditor Tara Kamp was unable to attend the meeting. Ms. Baker stated the audit findings for the Urban Renewal Agency (URA) for the fiscal year ending 2017 mirrored the City's audit; Pauly, Rogers and Co. issued an unmodified opinion on the URA's fiscal year ending 2017 financial statements with no exceptions or issues requiring comment for the State minimum standards nor was there a management letter issued. The unmodified opinion meant the Agency received a "clean" opinion with no reservations. It was the independent auditor's judgment that the financial records and statements were fairly and appropriately presented, and in accordance with GAAP. An unmodified opinion is the most common type of auditor's report and the desired result.

Board Member Groth moved to approve the fiscal year end 2017 Urban Renewal Agency audit. Board Member DiNovo seconded the motion which carried. Ayes: Benetti, DiNovo, Farmer, Groth, Kilmer, Kramer, Marler.

Approval of the Hollering Place Development Memorandum of Understanding

City Manager Rodger Craddock stated general terms and conditions for the development of the Hollering Place parcels were outlined in the attached memorandum of understanding (MOU) between the Urban Renewal Agency (Agency) and the Confederated Tribe of Coos, Lower Umpqua and Siuslaw Indians (Tribe). The Tribal Council approved the MOU and were asking the Agency for it's approval.
