### **Election of Agency Officers**

Board Member DiNovo nominated Stephanie Kilmer as Urban Renewal Agency Chair. Board Member Farmer seconded the motion. No further nominations were made. By action of Urban Renewal Agency ballot Board Member Kilmer was appointed Urban Renewal Agency Chair for a term ending with the next general biennium election.

Board Member DiNovo nominated Drew Farmer as Urban Renewal Agency Vice-Chair. Board Member Marler seconded the motion. No further nominations were made. By action of Urban Renewal Agency ballot Board Member Farmer was appointed Urban Renewal Agency Vice-Chair for a term ending with the next general biennium election.

Mayor Benetti nominated Lucinda DiNovo as Urban Renewal Agency Secretary. Chair Kilmer seconded the motion. No further nominations were made. By action of Urban Renewal Agency ballot Board Member DiNovo was appointed Urban Renewal Agency Secretary for a term ending with the next general biennium election.

# <u>Approval of a Proposed Facade Improvement Grant for 190 Johnson Avenue</u> (Domino's Pizza)

Public Works and Community Development Director Jim Hossley stated the new owners of 190 Johnson Avenue, Jerry and Brenda Hodges, requested approval of a facade improvement grant for exterior improvements to their building. They intended to convert the vacant warehouse building to a sit-down and take-out pizza restaurant. On April 10, 2018, they received land use approval from the Planning Commission through a site plan review application to remodel the interior and make exterior improvements to the structure. The structural valuation of the entire project was \$300,000. The exterior improvements were determined by the City's Building Department to meet or exceed \$50,000 in valuation.

With approval by the Urban Renewal Agency, the facade improvement program provided a 50/50 grant with a maximum grant award of \$25,000 per fiscal year. The facade improvement program required the submittal of three bids and a review by the Design Assistance Team (DAT). Staff requested an exception to those requirements because of the Planning Commission review, approval through the public hearing process, and the submittal of full site development and construction plans were already approved.

Board Member Benetti moved to approve proposed facade improvement grant for 190 Johnson Avenue, Domino's Pizza (Jerry and Brenda Hodges), for up to \$25,000 from the Downtown Urban Renewal facade improvement program. Board Member DiNovo seconded the motion which carried. Ayes: Benetti, DiNovo, Farmer, Kilmer, Marler, Matthews, Miles.

## Executive Session

Deputy Finance Director Melissa Olson read the executive session meeting disclosure statement. An executive session was held pursuant to Oregon Revised Statute (ORS) 192.660 (2) (e) for the purpose of discussing real property negotiations. No decisions were made.
