List as much information as possible about the historical significance of the site and/or building, including any of the following which are applicable: architect, builder, past residents, architectural style, method of construction, how the site relates to persons or events significant in local, state or national history.
 - C. Statement explaining why the resource should or should not be preserved or protected. Supporting evidence from a qualified resource specialist is encouraged.
 - D. If a demolition is proposed, attach a statement from the State Historic Preservation Office about the resource's value, and a structural survey by the City Building Official.
 - E. If an archaeological site will be disturbed, attach proof that the Coos, Siuslaw, and Lower Umpqua Tribal Council and the State Historic Preservation Office have been notified and given the opportunity to respond.
 - F. If an alteration to the property is proposed, attach proof that the proposed activity complies with state and federal requirements.
- 3. Address at least one of the following questions:
 - A. Does the cultural resource exemplify or reflect special elements of the City's cultural, social, economic, political, aesthetic, engineering, or architectural history;
 - B. It is identified with persons or events significant in local, state, or national history;

- D. Does the resource embody distinctive characteristics of a style, type, period, or method of construction or is it valuable as an example of the use of indigenous materials or craftsmanship?
- 4. Explain how the proposed is compatible with the character and value of the resource. Include the following information as applicable:
 - A. Building coverage and height.
 - B. Yards.
 - C. Predominant architectural features and fixtures, appurtenances, or detailing.
 - D. Building materials.
 - E. Visual characteristics, such as paint color and surface texture, grading, surface paving, and landscaping.
- 5. If you are proposing to demolish a structure or disturb an archaeological site, address the following information as applicable:
 - A. Is it not feasible to maintain or preserve the resource?
 - B. Have feasible alternatives to the proposed activity been explored?
 - C. Is the proposed use of the site or resource compatible with the zoning and current use of the land and its immediate surrounding?

- A. Attach (a) a certified list of names and addresses of all owners of property within 250 feet of the exterior boundaries of the subject property according to the latest adopted County tax roles and (b) an assessor's map showing all lots and parcels of land within that area.
- B. Provide evidence that you are the owner or purchaser of the property or have the written permission of such owner to make application for a cultural resources permit.
