Approval of the Minutes of the July 17, 2001 Meeting

Board Member Miller moved to approve the minutes of July 17, 2001 as presented. Board Member Weeks seconded the motion which passed unanimously.

Adoption of Resolution URA 01-03 – Approval of a Minor Plan Amendment to the Downtown Urban Renewal Plan Adding Interpretive Displays and Art work in the Boardwalk Area Associated with the Aquarium

Board Member Weeks moved to adopt Resolution URA 01-03 approving a minor plan amendment to the Downtown Urban Renewal Plan adding interpretive displays and art work in the Boardwalk area associated with the aquarium. Board Member Miller seconded the motion which passed unanimously.

Adoption of Resolution URA 01-04 – Approval of a Minor Plan Amendment to the Coos Bay Empire District Urban Renewal Plan Defining the Historic Downtown Core Area

Board Member Spangler moved to adopt Resolution URA 01-04 approving a minor plan amendment to the Coos Bay Empire District Urban Renewal Plan defining the Historic Downtown Core area, with an amendment to be added to allow purchase and disposal of property anywhere within the urban renewal district. Board Member Weeks seconded the motion for discussion. Chair Stufflebean asked for clarification if the amendment would be considered a minor or major plan amendment. After a short discussion it was concluded that Resolution URA 01-04 requires further explanation from the city attorney. The motion failed for lack of a majority vote. Board Member Spangler moved to table adoption of Resolution URA 01-04 until the September 18, 2001 meeting. Board Member Weeks seconded the motion which passed unanimously.
