Approval of a Façade Grant Morgan Veterinary Clinic

Joyce Jansen, Urban Renewal/Revitalization and Economic Community Development Manager, reported that Morgan Veterinary Clinic lost their awning due to a recent wind storm. Ms. Jansen said the Historic Design Review Committee reviewed the application on July 7th and recommended the Agency approve funding the Façade Grant. Ms. Jansen gave a brief description of the building and awning colors and commented that the Committee suggested reducing the size of the awning but the owner has decided to submit their original proposal rather than implement the change. Ms. Jansen said the total cost of the grant would be \$6,000. Board Member Muenchrath moved to approve the grant through the Façade Improvement Program. Board Member Melton seconded the motion which passed with Chair Eck and Board Members Burnette, Daily, Kramer, McKeown, Melton and Muenchrath voting aye.
